SUBJECT: Continuous Quality Improvement Tool and Process Updates

REQUIRED ACTION: Information Only I Time Sensitive I Immediate

On July 1, 2022, Adult Services Continuous Quality Improvement Specialist (CQI-S) began to use a newly revised CQI Assessment tool with County Departments of Social Services (DSS) at each quarterly consultation. The revised version of this tool was created in partnership with all 100 county DSS' who provided input via surveys and those counties that participated in the pilot group. The Adult Services Team has continued to connect with county DSS and the pilot group to receive feedback regarding the tool and processes related to the utilization of the tool.

In response to requests from our county DSS partners and in an effort to provide additional support, the CQI tool and processes are being updated as follows effective January 1, 2023:

Random Sampling of Records

- CQI-S will randomly select records for review. Counties can expect to receive the names for records no later than the 7th day of each calendar month prior to their scheduled consultation.
