

## **Achievements to Date**

- \$20 million committed to implementing three pilots to demonstrate Governor's task force recommendations
- \$20 million for increased rural crisis bed capacity for adults (\$18 million) and children (\$2 million)
- Partnership with DPI on Mental Health First Aid
- Additional \$658k in additional Substance Abuse and Prevention and Treatment Block Grant receipts were budgeted
- Naloxone state-wide order signed into law
- Needle exchange programs authorized and signed into law
- New Cherry Hospital facility adds Medical Psych unit and 116 new inpatient beds at full capacity
- Improvements to the Controlled Substance Reporting System



## **Behavioral Health Services**

- Establishment of Behavioral Health Services Subcommittees The most recent budget law, the 2016 Appropriations Act, provides that the HHS JLOC and the Medicaid JLOC shall each establish a subcommittee on Behavioral Health Services.
- These subcommittees shall meet jointly to do the following:
  - Oversee DHHS' development of the strategic statewide plan to improve the efficiency and effectiveness of state-funded behavioral health services (the development of this plan was required by the budget law);
  - Review this strategic plan, including reviewing the performance-related goals and measures for the delivery of mental health, developmental disabilities, substance abuse, and traumatic brain injury services.
  - Review consolidated monthly, quarterly, and annual reports and analyses of behavioral health services funded by Medicaid and State-only appropriations.
- The subcommittees shall jointly make recommendations about these areas of oversight and review and report their findings/recommendations to their respective JLOCs.
