NCATP Updates

Tammy Koger

- Federal Report Tammy & Kendal are currently working on the Federal Report. There are 11 different databases, and they have lots of bugs, so NCATP is currently working with a company called Embrex to develop a new database. It's in the beginning stages but will be much more functional.
- <u>April 17th</u> looks like it will be National AT Day Tammy submitted a proclamation to DHHS to have April declared as North Carolina's Assistive Technology month. We are waiting on feedback.
- Staffing Updates Vacant Outreach & Funding Position, which was previously held by Sonya Clark. We have submitted a candidate and hope to have the individual in place by January. Vacant Intake Coordinator position, but we do have a candidate in process. Kelly Towery joined NCATP staff in the Charlotte AT Center in an Admin position. Disability Rights of NC (DRNC)

Tara Muller

- NC's Protection and Advocacy Organization. P&A organizations are federally mandated, and services are free. They are allowed to have access to ANY facility where individuals are receiving treatment.
- They do a lot of outreach and self-advocacy. Also have an investigation team to ensure laws are followed and rights are protected.
- Disability Rights of NC sees frequent healthcare barriers and sometimes litigation is a tool used to have the most impact and reach the most individuals.
- They do have a team of Medicaid Attorneys can't help people get approved for Medicaid and/or Medicare, but they can help individuals get the benefits they are entitled to under the program.
- They also have an education team primarily to help ensure students stay in school. Lots of students with disabilities are not in school or not in the least restrictive environment because behaviors that are related to their disability became problematic. AT devices and access has often not been provided or even considered.

• Other teams include employment, monitoring, elections, justice, and home (IL). (see attached power point)
