# Minutes Well Contractors Certification Commission Meeting

# I. Preliminary Matters

- (1) Chairman Doug McVey called the meeting to order and requested cellular telephones be silenced.
- (2) Chairman McVey then read the NC State Government Ethics Act which mandates that the Chairman inquire as to whether any member knows of a conflict of interest or appearance of conflict with respect to matters before the Commission. The Chairman asked if any member knows of a conflict of interest or appearance of a conflict. No conflict of interest noted.
- (3) The chairman also read a statement on the purpose of the Well Contractors Certification Commission: (Article 7A-Well Contractors Certification, G.S. 87-98.3). **Purpose:** It is the purpose of this Commission to protect the public health and safety by ensuring the integrity and competence of well contractors, to protect and beneficially develop the groundwater resources of the State, to require the examination of well contractors and the certification of their competency to supervise or conduct well contractor activity, and to establish procedures for the examination and certification of well contractors.

#### II. Action Items

## (1) Approval of Minutes

The Commission reviewed the November 10, 2020 meeting minutes. Commissioner Young made a motion to approve the November 10, 2020 minutes. Vice-Chairman Muench seconded the motion. A roll call vote was taken and the motion passed unanimously.

## (2) Graduate Student Exemption

After lengthy discussion, Vice-Chairman Muench made a motion that graduate students are not exempt under 87-98.4 (4) public employee exemption. Commissioner Brown seconded the motion. A roll call vote was taken and the motion passed unanimously.

## (3) Contacting Legislature about Independence

Vice-Chairman Muench has contacted his Senator and Representative regarding WCCC independence. Commissioners and legal counsel requested minor revisions to the letter drafted for contacting the Legislature regarding independence from DHHS/DPH, then send the letter to Commissioners.

## (4) Removal of Vent Pipe

The Commission discussed removal of vent pipes from the well seal. Commissioners agreed that removal of the vent pipe is breaking the well seal and therefore a well contractor activity. Commissioner Deal made a motion that removal of a vent pipe is breaking the well seal and is a well contractor activity. Commissioner Brown seconded the motion. A roll call vote was taken and the motion passed unanimously.

#### (1) Chairman's Announcement

Chairman McVey announced he will be retiring from Buncombe County Environmental Health at the end of the month.

Chairman McVey presented the Disciplinary Committee report for meetings held on January 12, 2021. Raymond Brown, IV, NCWC 3308-A and Hester Blissard, NCWC 4375-A were both given a letter of reprimand based on the disciplinary requests received.

Commissioner Honeycutt presented the Budget Committee report for the meeting held on February 2, 2021. The Committee decided to have a booth at the 2021 Jubilee and NGWA events. Also, the Committee voted to have Mr. Morgan attend the NDA event in Charlotte this September.
