Background and Vision

In accordance with the American Rescue Plan Act of 2021, signed into law by President Biden, the North Carolina Department of Health and Human Services (NCDHHS) seeks to address systemic public health and economic challenges that have contributed to the impact of the COVID-19 pandemic.

NCDHHS is seeking to create a pool of qualified vendors and organizations that may support NCDHHS's response to the public health crisis created by COVID-19.

- This pre-qualification process will enable the Department to contract for various health services funded with ARPA dollars. Task Order (TO) requirements may call for solutions that cross over multiple UNSPSC codes to meet the needs of North Carolinians and coordinate contract management efforts.**

To view or print a solicitation document, click on the solicitation number. If an addendum has been issued, it will be located directly under the bid being modified and will be designated as an addendum.

Note: NCEP Sourcing solicitations and addenda are found in NCEP Sourcing, except for an addendum to extend the bid opening date, which will be located directly under the modified solicitation.

Solicitations for Statewide Term Contracts are in **RED** and solicitations for Agency Specific Term Contracts are in **GREEN**

It is the responsibility of the bidder to make sure that all addenda have been reviewed and, if need be printed, signed, and returned.

Check each solicitation document to verify the type of response required for that solicitation:

- Use the eBid button when the solicitation document indicates that NC BIDS must be used to submit your bid.
- Use the NCEP button when the solicitation document indicates that NCEP Sourcing must be used to submit your bid.
 - **Note: An Ariba network ID is required to respond via NCEP Sourcing.** If you do not already have an Ariba network ID, please begin responding at least 48 hours in advance to help ensure that your ID is created and your bid is submitted prior to the bid open date/time.
- For solicitations with no button, electronic bids are not permitted, submit a paper bid.

WHO SHOULD BE CONTACTED? If you are having difficulty retrieving a solicitation document, or the document is incomplete, click on the code or number listed in the HELP column to obtain assistance. This will bring up a new screen that will show the person to contact to help you retrieve the document. If, however, you have a question concerning the details of a solicitation, contact the purchaser listed in the solicitation document.

A WALK THROUGH THE ARPA PRE-QUALIFICATION OPPORTUNITY

The Announcement

- **Section 1.0 (p 1) of the Announcement provides an overview of the opportunity**
- **NCDHHS is seeking to create a pool of qualified vendors and organizations that may support NCDHHS's response to the public health crisis created by COVID-19**
- **This pre-qualification process will enable the Department to contract for various health services funded with ARPA dollars**
- **Task Order (TO) requirements may call for solutions that cross over multiple UNSPSC codes to meet the needs of North Carolinians and coordinate contract management efforts**
- **NCDHHS is committed to sustaining diverse pre-qualified vendor pools**
- **Competition is critical to public procurement, and we welcome questionnaires from all organizations who provide the services needed**

General Information

- **Section 2.0 GENERAL INFORMATION of the Announcement (p 2) includes important information about this opportunity. For example:**
 - **There are NO opportunities for IT services and equipment at this time**
 - **Pre-qualified organizations will be eligible to compete only for Task Orders issued under the commodity code(s) for which they were pre-qualified**

- **It is your responsibility to ensure questions are received by December 21, 2021, by 5:00PM ET unless changed via addendum**
- **It is your responsibility to ensure your pre-qualification questionnaire is submitted by January 24, 2022 by 8:00AM ET unless changed via addendum**
- **Plan in advance! Electronic does not mean instantly!**

Submitting Questions

- **Section 2.7: Announcement Questions (p 2)**
 - Again, questions are due on or before **December 21, 2021** by **5:00PM ET**
 - Questions must be submitted to:

 - Again, remember electronic doesn't mean immediate, so provide yourself with enough time for transmission!

Scope of Services

- **Section 3.0 (p 2) explains the scope of services anticipated for this pre-qualification process**
- **The ARPA Prequalification Opportunity comprises many areas of expertise and includes the requirements needed to form a total professional services solution necessary to meet Healthcare, Social Services, Public Health Services, and other related services**
- **The State reserves the right to offer multiple prequalification opportunities throughout the term of the Master Agreement**

Master Agreement

- **Section 4.0 (p 2) explains the intent and performance period of the Master Agreement**
- **The intent is to use this pre-qualification process to identify a pool of vendors that can provide the identified healthcare services resulting in a multiple award, indefinite delivery/indefinite quantity Master Agreement**
- **The Master Agreement will have a base period of performance from the date the Applicant is added to the pre-qualified vendor pool (“Execution Date”) through June 30, 2025, with two (2) optional one-year renewals**
- **Organizations will complete and sign a Master Agreement after they are pre-qualified**

Pre-Qualification Process

- Section 5.0 (p 3) explains the pre-qualification process
- Vendor prequalification is an information gathering and assessment process that facilitates the Department's determination of an organization's capability, capacity, resources, management processes, and performance
- **The ARPA Projects Portal is a web presence on the NCDHHS website developed to provide a one-stop resource for organizations to learn about and apply for prequalification**
- A Service Now application was developed to efficiently collect the information the Department requires to assess each organization's questionnaire
- Organizations will complete the application by commodity code, and organizations must submit an application for each commodity code
- Commodity Codes are in Attachment A of the Announcement

Pre-Qualification Process (continued)

- **The Pre-Qualification Process is 2-step:**
 - **Responsibility Determinations are either pass or fail based on whether the vendor has answered required questions acceptably and/or submitted required documentation. The Responsibility test must be passed before the organization's application can progress to Technical Evaluation**
 - **Technical Evaluations are conducted by Subject Matter Experts with specific knowledge and expertise relevant to the commodity code**

Procedures and Requirements

- **Section 6.0 (p 5) details the Department's instructions and requirements for your submittal. The Department reserves the right, in its sole discretion, to reject any response that fails to comply with the instructions**
- **It is your responsibility to follow all steps to complete your pre-qualification questionnaire**
- **Remember to review all addenda when preparing your response to ensure you complied with any changes**
- **Submission of late questionnaires, regardless of cause, is not supported by the Service Now application, and therefore, cannot be accepted, opened or considered**
- **The solicitation document in the Service Now application will be unavailable after the closing date**

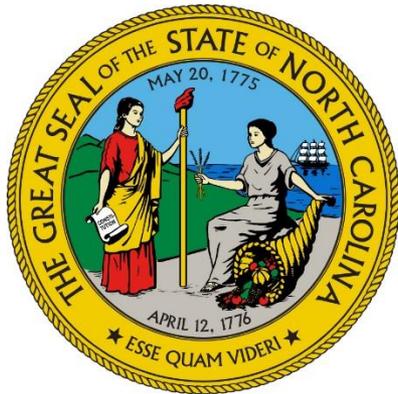
