RESULTS OF THE END OF YEAR 2023 SURVEY OF CIT PROGRAMS IN NORTH CAROLINA: A SUMMARY

Introduction

Since 2008, annual end-of-year surveys of North Carolina's Crisis Intervention Teams (CIT) have been conducted to measure progress in expanding CIT throughout our state. Respondents to the End of Year 2023 survey were asked to provide the names of law enforcement agencies participating in their local CIT program, the number of CIT law enforcement officers their program trained by <u>December31, 2023</u>, the number of tele-communicators or dispatchers that received CIT training by that date, and others who had received CIT training.

<u>Results</u>

Our 2023 end-of-year survey of North Carolina's CIT programs yielded the following results:

- Total number of NC law enforcement officers CIT certified by 12/31/ 2023: <u>18,805</u>
 - Number of NC law enforcement agencies participating in CIT in 2023: 231
 - Number of NC detention officers completing CIT training in 2023: 243
 - Total number of tele-communicators (dispatchers) CIT-trained by 12/31/2023: <u>1,855</u>
 - Total number of probation / parole officers completing CIT training in 2023: <u>37</u>
 - Total number of private security officers CIT-trained by 12/31/2023: <u>320</u>
 - Total number of fire fighters, EMTs and paramedics CIT-trained by 12/31/2023: 2512
 - Total number of others¹ who have received CIT training by 12/31/2023: <u>1,723</u>

An additional <u>1,423</u> CIT officers became CIT certified in calendar year 2023. There are approximately 18,680 police officers and 15,413 sheriff's deputies in North Carolina, for a total of 34,093 law enforcement officers in the state². The reader should note that the total numbers of CIT officers trained does not consider attrition over time.³

¹ Others include magistrates, NC State Bureau of Investigation (SBI) officers, National Park Service officers, Port Authority police, community college staff, department of social services staff, hospital staff, peer specialists, domestic violence shelter staff, victim's assistance staff, LME board members, animal control officers, provost marshals, private security, and officers from police departments in neighboring states.

² Statistics obtained in 2023 from the North Carolina Dept. of Justice, Training and Standards Division, and include only full time, sworn officers and deputies. Note: Some individuals may be dually certified as a police officer, sheriff's deputy and/or detention deputies so the counts may not reflect distinct individuals.

³ Data on CIT officers who have left their employment were unable to be obtained. Therefore, these data in this report does not reflect attrition among CIT officers and is almost certainly an overestimation of the actual numbers of CIT trained law enforcement employed in North Carolina.

The results of the End of Year 2023 CIT Survey yielded the following results per LME / MCO.

<u>ALLIANCE LME / MCO</u> - Serving Cumberland, Durham, Johnston, Mecklenburg, Orange, and Wake counties. Prior to 2023 Alliance had 4,113 CIT trained law enforcement officers and 557 CIT trained tele-communicators.⁴ Alliance had CIT programs in 6 counties in the Alliance catchment area in 2023.

In 2023, CIT programs in the Alliance area also provided CIT training to 67 EMS/Paramedics, 18 Detention Center staff,20 probation/parole officers, 38 telecommunicators, 3 Firefighters, 1 NCDPS Juvenile Department employee, and 32 others which includes civilians and other non-sworn staff at law enforcement agencies.

<u>EASTPOINTE LME / MCO</u> – Prior to consolidation with Trillium, Eastpointe served Duplin, Edgecombe, Greene, Lenoir, Robeson, Sampson, Scotland, Warren, Wayne, and Wilson counties. Eastpointe had 1,221 CIT trained law enforcement officers, and 158 CIT-trained telecommunicators. Eastpointe had CIT in 6 counties in the Eastpointe catchment area in 2023.

In 2023, CIT programs in the Eastpointe area provided CIT training to 12 Corrections officers, 31 EMS/Firefighters, and 19 telecommunicators.

<u>PARTNERS BEHAVIORAL HEALTH MANAGEMENT LME / MCO</u> – serving Burke, Catawba, Cleveland, Cabarrus, Davie, Gaston, Iredell, Lincoln, Surry, Rutherford, Union, and Yadkin counties. CIT in Forsyth County, which is in the Partners Catchment, is provided by Forsyth Mental Health Association. Partners catchment area has 1,408 CIT trained law enforcement officers and 129 CIT trained tele-communicators. Partners had CIT programs in 13 of the 14 counties in the Partners catchment area in 2023.

In 2023, CIT programs in the Partners catchment area provided CIT training to 12 Probation Officers, 70 EMS/Paramedics, 36 telecommunicators and 2 private security and 12 other Civilian/Community Collaborative Members.

Prior to 2023 Vaya had 1,434 CIT trained law enforcement officers and 74 CIT trained tele-communicators. Vaya has fully functional CIT programs in 16 of the 31 counties.

In 2023, CIT programs in the Vaya area provided CIT training to 29 EMS, 3 Probation and Parole/ Officers and 10 additional telecommunicators.

CIT Programs in 2023

CIT training happened in almost all 68 counties in the state in 2023. Many counties have CIT teams in multiple jurisdictions in their counties. CIT Programs, which are programs in counties where CIT is fully integrated into a crisis response collaborative. Currently there are CIT programs in 31 counties in the state. This is a change from previous years. The change can be attributed to the increased number of CIT Coordinators who have a better understanding of the requirements of what constitutes a CIT program vs CIT team.


CIT in Corrections in North Carolina


CIT training is also being provided to correctional staff in our North Carolina state prison system. The CIT community curriculum has been adapted by mental health professionals working in our prison system to better fit the correctional environment, with the goal of providing CIT training to all its correctional staff. There are 9038 certified correctional officers employed in the North Carolina prison system⁶. In 2023, CIT programs associated with the LME-MCOs assisted the Department of Public Safety by providing CIT training to 243 corrections officers in jails and State detention centers in North Carolina.

Summary

The Covid-19 pandemic presented unique challenges for CIT programs and resulted in a marked reduction in CIT trainings offered in the previous two years. However, by early 2023, most CIT programs began to schedule and plan for in-person trainings to begin in the Spring and throughout the remainder of the calendar year. CIT coordinators worked to creatively develop safe processes and still maintain the fidelity of the CIT model, all while promoting social distancing, encouraging mask wearing, having hand sanitizer available.

As many communities and law enforcement agencies have felt the need for more CIT trained officers, MCOs are acting diligently to schedule CIT as often as possible. The demand for CIT will likely continue to increase as communities continue to see an increase in behavioral health and substance use needs.

The State CIT Advisory Committee continues to meet every other month with a strong attendance and representation from law enforcement, advocates/NAMI, MCOs, behavioral health providers, community colleges, and others who have a vested interest in CIT. The Committee is in partnership with NAMI North Carolina to host the 2024 State CIT Conference in February 2024. The Committee has developed a relationship with CIT International. In 2023, 20 CIT Coordinators attended a Certified CIT Train the Trainer course in the state paid for by DMHDDSAS. A NAMI Guilford County representative has been received as a Board member with CIT International and has been a co-facilitator of the Statewide Advisory Council throughout the calendar year. The outlook for CIT in North Carolina, and as a state supported initiative, it is the common goal to support and strengthen CIT programs across the state.
