Subject: **Added Coding Instructions for Reporting Family and Children's Medicaid (NC MIC1) for Continuous Coverage Unwinding(CCU)**

Effective beginning with May 2023 services, with (NC Health Choice now titled) **NC MIC1** all DSS counties will use the following coding information to report the penetration rate cost for Family and Children's Medicaid expenditures from CCU for reimbursement on their DSS-1571 reports, excluding NAM Counties.

Part IB (Income Maintenance): Function Code 63 with

The related costs for "NC MIC1" are capped funds and will be tracked on the XS 411C report. Counties will continue to use app code 440. The program will draw overhead in your NC-CoRel's software in Income Maintenance.
