SUBJECT: SPECIAL ASSISTANCE COUNTY ADMINISTRATION

Effective with December 2012 services that will be reimbursed in January 2013, County Administration for Special Assistance Income Maintenance is considered a Medicaid administrative cost. Counties will be reimbursed for these administrative costs at the 50% Medicaid administration federal participation rate with county funds providing the required match. Prior to December 2012 services, county administrative costs for Special Assistance Income Maintenance were paid from 100% county funds. The change in funding will be reflected in your Budget Estimates for SFY 2013-2014.

Subject: Fiscal Reporting Procedures regarding State and County Special Assistance

Effective beginning <u>December 2012 services reimbursed January 2013</u> all counties, including Native American counties, will need to use the following codes to claim reimbursement for **State and County Special Assistance(S/C Spec Asst)** on their DSS-1571 report.

Part IA: (Income Maintenance - Salary and Fringe Benefits)

Application Code 444, Function Code 64, Column 09, State/County Special Assist 50% Federal funds and 50% County funds

Part II: (Administrative Expenditures and/or Purchased Services) There is <u>no</u> Part II coding requirements.

Part IV: (Purchased Services requiring client ID) There is no Part IV coding requirements.

CFDA number for this fund is 93.778. The related cost for application code 444 will<u>not</u> be tracked on the DHHS XS411c report. In terms of overhead for the application code in your Maximus software, this program will <u>not</u> draw overhead from Service Supervision & Clerical, IV-D Supervision & Clerical or Joint Service & IV-D Workers.
