### SUBJECT: Money Smart for Older Adults Curriculum Train the Trainer Events

As you know all too well, financial exploitation is a growing problem for older adults. To increase awareness of this issue and help prevent it, the consumer Financial Protection Bureau (CFPB) and the Federal Deposit Insurance Corporation (FDIC) issued the *Money Smart for Older Adults* (MSOA) curriculum in June 2013. MSOA offers information and tips to older adults to help them prevent fraud, scams, and other types of financial exploitation.

The agencies and organizations below have formed a strategic alliance to disseminate this proactive education to as many older adults in North Carolina as possible.

Interested representatives from these organizations, agencies and networks have the opportunity to be trained by State Employees' Credit Union (SECU) staff to deliver the *Money Smart for Older Adults* curriculum. Train the trainer sessions will be held at regional locations in May and June of 2014, running in conjunction with North Carolina's Elder Abuse Awareness month which begins on Mother's Day and ends on Father's Day.

### **REGISTRATION INFORMATION**

Train the trainer sessions will be held in Fayetteville, Charlotte, Asheville, Goldsboro, Greenville, Raleigh, and Greensboro. There will be two training sessions per day at each location – 9am-12pm and 1pm-4pm. Since there is limited seating at each site, each agency will be asked to register one representative for the morning and one for the afternoon session at a specific location.
