Subject: Adult Care Home Resident Discharge Team Webinar

The Adult Care Home Resident Discharge Team webinar is now available. This webinar is intended to instruct the staff of county departments of social services (DSS), Local Management Entities (LME), and adult care home/family care homes in meeting the requirements of House Bill 677 which requires every county to establish a Adult Care Home Resident Discharge Team (ACHRDT) if the county has an adult care home licensed under Chapter 131D of the General Statutes.

The <u>Adult Care Home Resident Discharge Team Procedure Manual</u> was developed in conjunction with the Division of Mental Health, Developmental Disabilities and Substance Abuse Services (MH/DD/SAS) to provide guidance as to the function and responsibilities of the Adult Care Home Resident Discharge Team.

The webinar has a 100 slot capacity per session. There are six sessions scheduled. Sessions will be divided into regions with 20 counties participating at one time. **All County DSSs, LMEs and Adult Care Home/Family Care Home staff within that 20 county region are invited to participate**. County DSSs/LMEs/ACH/FCH are asked to have no more than two slots occupied per session. Agencies are strongly encouraged to have multiple staff view the presentation on a single computer or project the webinar on a screen. The sixth session will be for those who were not able to attend the first five sessions due to scheduling or because a previous session was full. The ACHRDT webinar will be recorded and archived for future use.
