SUBJECT: Adult Protective Services Survey

Attention: Adult Services Supervisors

The Division of Aging and Adult Services (Division) is conducting the Annual Survey of North Carolina's Adult Protective Services Program (APS) to collect crucial information about the needs of vulnerable older adults and adults with disabilities who come to the attention of your agency. Data from the annual survey provides essential information to help strengthen North Carolina's APS program. For example, survey data, used in conjunction with the APS Register data, is used to respond to media requests for information, requests for data from national surveys, provide reliable data for the Attorney General's Task Force on Fraud Against Older Adults, support our continued efforts to pilot the proposed Vulnerable Adult Protection System (VAPS) and to prepare North Carolina to receive Elder Justice Act funding when it becomes available. As you know, some funding for the Elder Justice Act, Title VI of the Patient Protection and Affordable Care Act, was included in the President's 2012 and 2013 budgets.
