# Crossroads Upgrade 1.31 – Summary of Changes

The North Carolina Women, Infants, and Children (WIC) Crossroads system will release a new software version (1.31) to local agency users on Monday, September 11, 2023. This upgrade coincides with the changeover of the NC Electronic Benefits Transfer (EBT or eWIC) provider from Solutran to FIS/CDP. This document summarizes the improvements included with the upgrade as well as important notes about functionality changes.

### I. Transfer Between Families / Gap in Benefits

Transferring between families appears to be working much more smoothly in 1.31. Please examine the **Shopping List** of transferred participants carefully. Notice that the issuance to cover any gap in benefits appears with **new dates** but the **same Food Instrument number** (as shown in the sample Shopping List below). This issuance is expected and is NOT overissuance.

## Crossroads Upgrade 1.31 – Summary of Changes

#### Foster Children: Change to CNDS ID

A foster child will continue to have a separate Electronic Benefits Account (EBA), eWIC Card and EBT Activity History. Their participant ID (CNDS ID) used in Crossroads is also their EBA number. If the foster child's CNDS ID changes for any reason in the middle of an issuance cycle (after benefits have been issued and before all benefits for the month have been redeemed), the risk is very high that the foster child will also need a new eWIC card issued. This is a Crossroads defect that we have escalated to both the Crossroads computer vendor AND our EBT provider. Any time the local user changes a CNDS ID for a foster child, also verify that benefits are available on the most recent card by printing/previewing the **Shopping List**. If benefits are not available, contact the Customer Service Desk (CSD) for assistance.

#### **Terminating Participants**

If a participant is terminated in Crossroads, their EBA remains active with the EBT provider. One of two actions MUST be taken after terminating participants in Crossroads:

- 1. Deactivate the family's eWIC card on the Issue EBT Card screen OR
- 2. Void any current and future benefits on the **Food Instrument List** screen.

Deactivated eWIC cards are listed **twice** in EBT Card History: once with the Deactivated Date in Eastern Standard Time (EST) and once with the Deactivated Date in Greenwich Mean Time (GMT). Note: GMT is 4 hours later than Eastern Standard Time (EST).

#### Journal of Transactions (JOT): Purchases

With the new eWIC provider, JOT: Purchases will occur in real time. You will not need to wait for an overnight batch process to view the participant's purchases. Purchases will display the time in GMT which is 4 hours later than EST. Example: Transaction Time: 9:27 PM (GMT) is equal to 5:27 PM (EST)

#### **New Reports**

Two new reports have been added to Crossroads in the Appointments category:

- Detail Nutrition Education Appointment Schedule with Phone
- Appointment History Report with Phone

### Reminder!

On the Exchange/Increase formula screen, current Crossroads functionality is:

- Add Formula DOES prorate.
- Exchange Formula does NOT prorate. Formula is exchanged on an ounce for ounce basis (Reconstituted Fluid Ounces, not can/container size).
- Increase Formula does NOT prorate. Please contact the CSD if you need the amounts of an increased formula to be prorated.

### **Best Practice for eWIC!**

Always verify that food benefits have been issued to participants by selecting the **Print Shopping List** button on the **Food Instrument List** screen and reviewing the **Shopping List**. Verification of food benefit issuance is a best practice that should happen at any appointment when food benefits are issued, voided, exchanged, replaced or increased. Missing or incorrect food benefits can be corrected by contacting the CNSS CSD.
