Crossroads Upgrade 1.32 – Summary of Changes

The North Carolina Women, Infants, and Children (WIC) Crossroads system will release a new software version (1.32) to local agency users on Monday, March 11, 2024. This document summarizes the improvements included with the upgrade as well as important notes about functionality changes.

Redesign of Exchange/Increase Formula Screen

The **Exchange/Increase** Formula screen in the **Issue Benefits Quick Links** of Crossroads has been redesigned for easier staff use and to correct several long-standing defects. The screen now starts with a section asking for staff intent:

What do you need to do?

- Increase the amount of current formula given to the infant (Increase Formula)
- © Exchange the current formula for the same amount of a different formula (Exchange Formula)
- Exchange the current formula for an increased amount of a different formula (Exchange and Increase Formula)
- Issue WIC Eligible Nutritional or formula to a participant who does not currently receive it (Add Formula)

On the Exchange/Increase Formula screen, Crossroads functionality is:

- Add Formula DOES prorate.
- Increase Formula DOES prorate.
- Exchange Formula does NOT prorate.
 Formula is exchanged on an ounce for ounce basis (Reconstituted Fluid Ounces, not can/container size).

Generate New ID

On the Certification Summary screen, the **Generate New ID** button is now enabled for every certification status: Applicant, Active, Deceased, Expired, Terminated. This button is most often used in the cases of duplicate participants and allows users to release the participant's current CNDS ID to assign it to a different record.

Journal of Transactions (JOT) Occurrence Date for Activity: Certification

The JOT Occurrence Date: Certification is now the date the subsequent certification was **completed**. For Infants and Children, the Certification Start date may not match the JOT Occurrence Date if the subsequent certification was completed early.

Participants in Military Families Report

The **Detail Participants in Military Families Report** will list participants from any family who has *National Guard* or *Active Military* checked under **Military Status** on the **Family Demographics** Quick Link in Crossroads. This report is accessed from the Clinic Report Category.

Use the following search parameters: From/To Date: Certification dates for participants with Military Status recorded. State: North Carolina WIC Program Report Type: Clinic OR Local Agency

The report lists Family ID, Parent/Guardian Name, Participant ID, Participant Name, WIC Category, Cert Start Date, and Cert End Date. See Sample below.
