The following changes have been made to the Federal Parent Locator Service (FPLS) State Services Portal (SSP) by the Office of Child Support Services (OCSS):

January 2025:

- Security of the Portal is enhanced by requiring users to acknowledge that they have read, understand, and agree to the Rules of Behavior before accessing the Portal.
- The Log In Certification page is updated with a link to the Rules of Behavior. All Portal users, including states, are required to accept the Rules of Behavior to meet the updated security requirements. Users must select both the "I Accept" checkbox and Agree button to proceed.

March 2025:

- User accounts will be deactivated if there has been no activity on the Portal in 30 days. Following account deactivation, users will need to verify and update, if necessary, their first and last name, email address, phone number, and extension on the Verify User Profile Information page the next time they access the Portal.
- In order to comply with U.S. Web Design System (USWDS) standards, buttons and page layouts will look different. The Welcome to the Child Support Portal page is left justified for this release to comply with these guidelines.
- A new "Employer Services" category with thirty-nine related questions has been added to the Interstate Reference Guide (IRG) to improve it.
