Effective April 28, 2025, the following 11 counties will begin using eCourts, which is a part of the Administrative Office of the Courts (AOC) new integrated case management system, Enterprise Justice: *Bertie, Edgecombe, Greene, Halifax, Hertford, Lenoir, Nash, Northampton, Pitt, Wayne, and Wilson.*

From April 23 – April 27, 2025, AOC will not make any updates to cases in these counties in the SES/Legacy system, and starting April 28, AOC cases and court information for these counties will only be viewable in the eCourts portal. These 62 counties have already transitioned to eCourts: *Alamance, Anson, Beaufort, Bladen, Brunswick, Buncombe, Cabarrus, Camden, Carteret, Chatham, Cherokee, Chowan, Clay, Columbus, Craven, Cumberland, Currituck, Dare, Duplin, Durham, Franklin, Gates, Graham, Granville, Guilford, Harnett, Haywood, Henderson, Hoke, Hyde, Jackson, Johnston, Jones, Lee, Macon, Martin, Mecklenburg, Montgomery, Moore, New Hanover, Onslow, Orange, Pamlico, Pasquotank, Pender, Perquimans, Person, Polk, Randolph, Richmond, Robeson, Sampson, Scotland, Stanly, Swain, Transylvania, Tyrrell, Union, Vance, Wake, Warren, and Washington*

A statewide rollout of eCourts is planned for completion by the end of 2025. You will be notified in advance when other counties are expected to transition to the new system.
