PURPOSE: The North Carolina Department of Health and Human Services (NCDHHS), Division of Social Services (DSS), along with the Center for Child & Family Health (CCFH) will be hosting seven (7) regional listening sessions in January 2024. These virtual sessions are being held to gain an understanding of the impact of job stress on our current child welfare workforce (including secondary traumatic stress) and the current well-being needs of our child welfare workers. This information will be used to understand how DSS agencies can address workforce stress and wellness at an organizational level. A secondary goal of the sessions is to learn about practices currently being implemented that are helping to sustain the workforce and to share these practices across regions.

Child Welfare front line workers and supervisors, who wish to share what is or is not working well in managing stress in child welfare, are invited to join any one of the following sessions:
