North Carolina Division of Social Services provides interstate services to ensure the safety and well-being of children and youth who are placed across state lines. The Interstate Compact on the Placement of Children (ICPC) is a statutory agreement that establishes specific requirements that must be met before a child or youth can be placed out of state. To assist in the provision of these services, an ICPC consultant is assigned to each county.

Please see the attached document for the revised county assignment list for each ICPC Consultant. In addition, our office has a new ICAMA Consultant. The Interstate Compact on Adoption and Medical Assistance (ICAMA) protects the interstate interests of children covered by an adoption assistance agreement when they move or are adopted across state lines.
