PURPOSE: FUNDING AUTHORIZATIONS AND CORRECTION TO FAMILY REUNIFICATION SERVICES FUNDING

Funding Authorizations

The North Carolina Division of Social Services (NCDSS) published Funding Authorizations for County DSS agencies, indicating available funding/budgets for various programs. Those can be found at: https://www.ncdhhs.gov/divisions/social-services/county-staff-information/budget-information/information-county-departments-social-services#FundingAuthorizationsforSFY2023-24-4871. As you are aware, counties can claim reimbursement up to the maximum amount allocated in the individual funding authorization.

There was a delay in the release of some Funding Authorizations at the beginning of this fiscal year, with some not released until early October. This was related to the state budget not being passed at this point. However, when Funding Authorizations are not released, the County Admin Reimbursement System (CARS) does not have a cap in place until those Funding Authorizations are coded in. This led to overpayments to some counties for the Family Reunification fund, those who in the first quarter keyed for reimbursement amounts above the annual Budget Estimate value. Once the Funding Authorizations were released, counties who received reimbursements above that amount had the overage reclassed to all-county funding, as is the normal course of operations for overages. Those counties who did not overclaim budget in this timeframe felt no impact.

In addition to this issue, NCDSS previously provided guidance on the Family Reunification Services through a Dear County Director Letter (DCDL), dated September 28, 2023. This DCDL instructed county child welfare agencies to stop submitting requests to NCDSS for reimbursement of federal funds for Family Reunification Services. At that time, there was concern that all funds had been utilized. However, that was not the case. This issue was recognized, Funding Authorizations were released in early October and correcting entries had been made in CARS. No further action is needed on your part. We apologize for the confusion generated by this issue.
