## SUBJECT: SURVEY FOR INTERSTATE COMPACT ON THE PLACEMENT OF CHILDREN

## **REQUIRED ACTION:** Information Only Time Sensitive Immediate

North Carolina Division of Social Services (NCDSS) is committed to improving the services of the Interstate Compact on the Placement of Children (ICPC). ICPC allows states to have prospective placement resources evaluated to ensure a child would receive proper care and supervision prior to a child being sent to an out of state placement. The 2024 Annual Progress and Services Report (APSR) identified that NC needs to improve the use of cross-jurisdiction resources via ICPC to facilitate timely adoptive or permanent placements for children.

The Deputy Compact Administrator for Interstate Services with the North Carolina Division of Social Services, Althea Swinson, is currently a fellow for The Minority Professional Leadership Program (MPLD) through AdoptUSKids. MPLD allows fellows to complete an Action Research Project (ARP) to address issues in their agencies related to adoption, guardianship, or kinship. During the fellowship, Ms. Swinson will design and implement actions to strengthen the county agency's knowledge and best practice for ICPC placements to improve permanency outcomes.

Since the ICPC process is an essential resource to achieving permanency, we are asking that all child welfare staff complete the ICPC survey. The purpose of the survey is to assess the current ICPC process and the impact on permanency outcomes for children placed across state lines.
