<b>Abuse:</b> Physical Injury	<b>Abuse:</b> Physical Abuse <ul style="list-style-type: none"> <li>-Serious Physical Injury inflicted by action of caretaker</li> <li>-Unexplained physical injury</li> <li>- Excessive or cruel punishment</li> <li>- Substantial risk of physical harm <ul style="list-style-type: none"> <li>-Threatening or dangerous behavior toward a child</li> </ul> </li> <li>-Near Fatality</li> </ul>
<b>Abuse:</b> Sexual Abuse	<b>Abuse:</b> Sexual Abuse <ul style="list-style-type: none"> <li>-Any sexual act on a child</li> <li>- Any sexual act on a child by an adult caretaker or other adult in the household</li> <li>-Physical or behavioral indicators consistent with sexual abuse</li> <li>-Exposure to sexually explicit conduct or materials</li> <li>-Sexual exploitation</li> <li>-Caretaker knowingly allows a person with a history of sexual offenses against minors to have unsupervised and/or unrestricted access to the child.</li> <li>- Substantial risk of sexual abuse</li> </ul>
<b>Abuse:</b> Emotional Abuse	<b>Abuse:</b> Emotional Abuse, Mental Injury
<b>Abuse:</b> Moral Turpitude	<b>Abuse:</b> Encouraging or Enabling Delinquent Offense, Moral Turpitude
<b>Abuse:</b> Human Trafficking <ul style="list-style-type: none"> <li>-Sex Trafficking</li> <li>-Labor Trafficking</li> </ul>	<b>Abuse:</b> Human Trafficking of a Minor <ul style="list-style-type: none"> <li>-Child sex trafficking</li> <li>-Child labor trafficking, involuntary servitude of a child</li> <li>-Child trafficking</li> </ul>
<b>Neglect:</b> Improper Care	<b>Neglect:</b> Physical Neglect <ul style="list-style-type: none"> <li>-Unsafe living conditions <ul style="list-style-type: none"> <li>- Exposure to methamphetamine production</li> </ul> </li> <li>-Unsafe clothing or hygiene</li> <li>-Unsafe food/nutrition</li> </ul> <b>Neglect:</b> Educational Neglect

<b>Neglect:</b> Refusal to participate in Juvenile Justice recommendations	<b>Neglect:</b> Physical Neglect -Parent, guardian, or custodian has refused to follow the recommendations of the Juvenile and Family Team
<b>Neglect:</b> Improper Supervision	<b>Neglect:</b> Physical Neglect -Unsafe supervision/child left alone
<b>Neglect:</b> Unsafe Discipline	<b>Neglect:</b> Physical Neglect -Unsafe discipline
<b>Neglect:</b> Improper Medical/Remedial Care	<b>Neglect:</b> Medical Neglect -Physical health -Medical neglect of a disabled infant with a life-threatening condition -Mental health
<b>Neglect:</b> Illegal Placement/Adoption	<b>Neglect:</b> Illegal Transfer of Custody
<b>Neglect:</b> Injurious Environment	<b>Neglect:</b> Exposure to violence in the home, injurious environment
<b>Neglect:</b> Abandonment	Unchanged
<b>Neglect:</b> Injurious Environment -Substance Abuse -Substance Affected Infant -Domestic Violence	**Substance abuse has been removed as a maltreatment option <b>Neglect:</b> Physical Neglect -Unsafe living conditions -Exposure to methamphetamine production -Substance-affected infant -Exposure to violence in the home, injurious environment
<b>Neglect:</b> Request Dismiss Safe Surrender	<b>Neglect:</b> Parent Requests to Dismiss Safe Surrender
<b>Dependency</b>	<b>Dependency</b> -Caretaker incapacity -Safe surrender Infant
N/A	<b>Maltreatment Undetermined</b> ***This can only be chosen as an option for a child in a home where a previous maltreatment has already been chosen for another child in the home.
