### PURPOSE: ADDITIONAL CHAFEE FUNDS UPDATE AND SERVICES SURVEY

#### Chafee (LINKS) Housing and Transitional Funds

The John H. Chafee Foster Care Independence Program, LINKS in North Carolina, assists current and former eligible foster care youth and young adults achieve self-sufficiency through support services, resources, and LINKS Special Funds. LINKS Special Funds are also known as North Carolina's transitional and housing funds. Thank you for your continued hard work to provide services, guidance, resources, and support to our LINKS and Foster Care 18 to 21 young adults. In support of your efforts with the LINKS Program, the transitional and housing special LINKS funds have been increased and are available for your use.

Transitional funds are available for youth and young adults in North Carolina who are ages 14 to 21, and currently in foster care or were in foster care at age 14 or older with life goals and needs connected to LINKS outcomes. Transitional funds have increased by \$100,000 for fiscal year 2021-2022.

Housing funds are available to assist North Carolina's young adults who aged out of foster care at 18 but are not yet 21 years of age with rent, rent deposits, room and board, or down payments on housing. LINKS housing funds have been increased by \$50,000.

We are working to strengthen Chafee services in North Carolina and for fiscal year 2022-2023, housing funds and transitional funds will be increased by \$100,000. To ensure county reimbursements are available for fiscal year 2021-2022, please contact your State LINKS Coordinator, Tori Marshall for confirmation before spending and requesting county reimbursements. Recent reimbursements have been processed. Below are the remaining balances for housing and transitional funds but can vary by availability.
