North Carolina Division of Social Services (NCDSS) would like to thank you for the tremendous support on the NYTD surveys. We are now preparing for the National Youth in Transition (NYTD 2023B) baseline reporting period that began on April 1, 2023, and ends September 30, 2023.

Each county agency will be provided an NYTD eligible youth list by email and all eligible youth must complete the survey within 45 days of their 17th birthday. It is recommended to have the survey completed as soon as the option is available. Youth participating in the baseline cohort will remain a part of the 19-21 follow up population. The NYTD 2023B stipend incentive is now \$100.00 for the participating youth.

Technical Assistance (TA) will be available on Friday, May 5^{th,} 2023, from 11:00 AM–12:00 PM to explain and assist with any questions.
