SUBJECT: Newly Published Evidence- Based Prevention Services Policy

North Carolina Division of Social Services is committed to providing services that prevent entry into foster care. Evidence-Based Title IV-E Prevention Services support this goal and are IV-E reimbursable under the Family First Prevention Services Act to cover certain expenditures and services related to preventing foster care placements. Evidence-Based Prevention Services should be considered as an option for all cases in which a child(ren) is determined to be a candidate for foster care during the provision of In-Home services.

The first service to become available under this new federal IV-E funding stream is Homebuilders. Homebuilders is an intensive family preservation program that has shown, when used to fidelity, to support families with stabilizing crises that place children at risk of out of home placement.

To support Child Welfare workers, supervisors, program managers and administrators with completing the required Title IV-E Prevention Services eligibility determination process for the new programs, NC DSS has developed and posted the Evidence-Based Prevention Services policy.
