The North Carolina Department of Health and Human Services (NCDHHS), Division of Social Services (DSS), along with the Center for Child & Family Health (CCFH) will be hosting two webinars to help child welfare professionals move from Policy to Practice in the delivery of trauma informed child welfare services. Policy to Practice Part 1:

Trauma Screening & Family First Prevention Services (FFPSA) Implementation Monday, May 1, 2023, from 2:00-3:00pm

This webinar will provide information about the use of the NC Child Welfare Trauma Screening Tool and the role it will play in the statewide implementation of the Family First Prevention Services Act (FFPSA). Participants will be provided information on the background of the trauma screening tool, how it has been used to identify trauma in the child welfare involved population, how it helps determine appropriate trauma interventions for children and youth, its role in helping North Carolina meet federal mandates, and the role of the trauma screening tool in FFPSA implementation. At the end of the webinar participants will have a greater understanding of the NC Child Welfare Trauma Screening Tool and its applications to their child welfare practice as an important part of their child welfare agency's trauma-informed practice.
