SUBJECT: EVERY STUDENT SUCCEEDS ACT (ESSA) POINTS OF CONTACT

REQUIRED ACTION: Information Only I Time Sensitive I Immediate

PURPOSE: NOTIFICATION OF ESSA POINTS OF CONTACT

In 2015, Every Student Succeeds Act (ESSA) was signed into law. A component of ESSA is to uphold critical connections for America's disadvantaged and high-need students. Children and youth experiencing foster care are eligible for additional supports because of ESSA. These provisions (ESSA Foster Care) complement the requirements of the Fostering Connections to Success and Increasing Adoptions Act of 2008 (Fostering Connections Act). These laws strengthen opportunities for educational agencies and child welfare agencies to jointly determine the most effective practices while promoting school stability and success for students.

For the Department of Public Instruction (DPI), ESSA requires greater protections for all disadvantaged and high-need students, including students in foster care. One such protection includes the requirement that the academic performance of these students must be tracked. To facilitate implementation of ESSA as it applied to students in the custody of a county child welfare agency, DPI partnered with the SERVE Center at The University of North Carolina at Greensboro. The SERVE Center provides training to DPI staff and works to ensure DPI complies with ESSA requirements. NCDSS and NC DPI will collaborate to provide training to county child welfare agency ESSA points of contact in the Fall of 2022.

Next Steps:

To ensure DPI has the correct person of contact for each County DSS agency, county child welfare agencies must immediately take the following steps:

- 1. Go to <u>https://serve.uncg.edu/projects/nc-foster-care/</u> and scroll to the bottom of the page.
- 2. Click on "Child Welfare ESSA Point of Contact" to open an Excel spreadsheet to determine if the person of contact is current.
- 3. If the person of contact needs to be updated, please return to the website, and click on "Contact Information form for the NC Welfare Agency Point of Contact."
