SUBJECT: NALOXONE GUIDANCE FOR NCDSS LICENSED GROUP HOMES

REQUIRED ACTION: Information Only Time Sensitive Immediate

North Carolina Division of Social Services (NCDSS) is committed to ensuring that public and private agencies that provide foster care services to children in NCDSS licensed group homes have the resources they need to ensure the safety of children.

Opioid misuse is an epidemic throughout the United States and North Carolina. Between the years 2000 and 2022, more than 36,000 North Carolinians have lost their lives to drug overdose. Naloxone is an antidote to opioid overdose and as an opioid antagonist, it is used to reverse the effects of opioids. NCDSS is providing the attached guidance, Naloxone Guidance for Residential Child Caring Facilities, for NCDSS licensed group homes to follow if the NCDSS licensed group home chooses to obtain, store, and administer Naloxone for any suspected opioid overdoses.
