PURPOSE: NOTIFICATION OF PERMANENCY PLANNING POLICY UPDATES

The North Carolina Division of Social Services (NCDSS) is committed to providing counties with protocol and guidance to support compliance with the law and best practice of child welfare services. There were changes to the law regarding child welfare during the 2021 legislative season. Session Law 2021-132 was enacted on October 1, 2021. This law addresses safe and appropriate placement for children in need of mental health services including the roles and responsibilities of the Rapid Response Team. The Permanency Planning Manual has been updated to reflect these changes to the law. Additionally, and in the interest of clear instructions, a DSS form (DSS-6190) has been created for counties to utilize when making referrals to the Rapid Response Team.

The policy was published May 18th, 2022 and can be found on the Division's web page at https://policies.ncdhhs.gov/divisional/social-services/child-welfare/policy-manuals.

The revised changes in the Permanency Manual are as follows:

- Requirements when a juvenile in the custody of the Department of Social Services presents to a hospital emergency department for mental health treatment
- Referral process to the Rapid Response Team
- Court procedure for an emergency motion for placement and payment
