The Children's Alliance of Kansas is the purveyor of the MAPP series and has revised *TIPS-MAPP* into an updated course, *MAPP Foundations*. The North Carolina Department of Health and Human Services (NCDHHS) will begin transitioning from TIPS-MAPP to MAPP Foundations starting in August 2025 with full implementation expected by June 30, 2026. This updated version includes new video content, enhanced information on brain science and trauma, updated child scenarios, and expanded materials for birth families, among other improvements. This transition will kick off during the week of August 11-15, 2025, and there will be three, one-day, TIPS-MAPP to MAPP Foundations Leader Certification Update sessions offered to currently certified NC TIPS-MAPP Leaders. 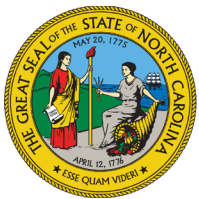
