SUBJECT: June is National Reunification Month

REQUIRED ACTION: Information Only I Time Sensitive I Immediate

In June 2010, the American Bar Association (ABA) Center on Children and the Law and other stakeholders designated June as National Reunification Month. Reunification is the most desirable and positive legal permanency option for children. This year's theme is "*Shifting Power and Reconnecting Families All Year Long*."

In the spirit of Reunification Month, North Carolina Division of Social Services (NCDSS) would like to take time to celebrate reunification efforts for children and families who experience foster care. Father's Day also falls during the month of June. NCDSS would also like to recognize the importance of fathers in their children's lives, and the commitment to engaging fathers who experience child welfare involvement.

NCDSS is committed to providing resources that can be accessed by county DSS staff and private licensing agency staff in supporting reunification efforts and actively engaging fathers.

Reunification Resources:

Foster Care Appreciation Event and Reunification Celebration: A <u>DCDL</u> was issued on May 17, 2022, notifying county agencies and private licensing agencies of an event being held on June 17, 2022. This event will highlight reunification as the most desirable legal permanency option for children. The event will have guest speakers, music, and provide free food and drinks. Permanency Roundtables: The Permanency Roundtable Program seeks to achieve permanency for youth in foster care by addressing the youth's immediate, critical need for permanency as they approach the age of 18. Achieving permanency through reunification, adoption, guardianship, or another lifelong supportive relationship is one way to mitigate the negative outcomes that are probable for youth who would otherwise "age out" without permanent families or positive connections. By offering a structured, targeted approach, the Roundtables can help restore hope for these youth and increase the probability of their achieving permanency, even under difficult circumstances.

There are several counties currently participating in Permanency Roundtables with Cindy Hamilton of Linear Consulting, LLC. The participating counties have provided positive feedback regarding their experience and the permanency outcomes from these roundtables.
