# ATTENTION: DIRECTORS, CHILD WELFARE PROGRAM ADMINISTRATORS, MANAGERS, SUPERVISORS, AND CHILD WELFARE STAFF

#### SUBJECT: CRIMINAL HISTORY RECORD INFORMATION (CHRI) FOR POTENTIAL ADOPTIVE PARENTS

#### **REQUIRED ACTION:** Information Only I Time Sensitive I Immediate

The North Carolina Division of Social Services (NCDSS) is working collaboratively with the Division of Child Development and Early Education (DCDEE) to provide updates about accessing the Criminal History Record Information (CHRI) for potential adoptive parents.

This letter is a follow-up to the initial DCDL (CWS\_23\_2023) sent on April 26, 2023, where each county was required to submit the names of each staff member designated to access CHRI to ensure the mandated training was available to staff. Currently we have 45 counties reporting 100% compliance, 47 counties reporting partial compliance and 8 counties that are not in compliance with the federal mandate.

Starting July 1, 2024, there will be a procedural change. DCDEE will be rejecting all applications from counties without 100% CJIS compliance. DCDEE does not have the ability to manage CHRI once it has been distributed to the counties. Therefore, the new procedure will ensure all DSS County staff tasked with reviewing CHRI are authorized to do so per the FBI's requirements. DCDEE will be reaching out to each individual county and reviewing the list of social workers to verify current social workers and any that need to be deactivated.

As a reminder, when all designated employees in each county have completed the training, the county should send all certificates together to <u>DHHS.CBC.Adoption@dhhs.nc.gov</u>.The certificates *must* be received by the CBC Unit, before the CHRI information can be released to designated staff.
