## PURPOSE: COUNTY SURVEY SUBMISSIONS FOR THE NATIONAL YOUTH IN TRANSITION (NYTD 2022B) DATABASE

North Carolina Division of Social Services (NCDSS) current response rate for the National Youth in Transition (**NYTD 2022B)** Database is at 47% for the reporting period from **April 1, 2022–September 30, 2022.** Thank you for your dedication and diligence in locating survey-eligible young adults.

While NCDSS remains excited about our response rate, Public Law 106-169 established the John H. Chafee Foster Care Independence Program at section 477 of the Social Security Act which was amended by the Family First Prevention Services Act of 2018 (Public Law 115-123) and mandated the NYTD benchmarks for NYTD data collection for states. North Carolina must reach a benchmark of 80% to achieve our goal. NCDSS must report on our independent living services and other supports provided to all youth based on our eight LINKS outcomes. The steps to ensure timely completion and submission of surveys for eligible youth are as follows:

- 1. You may request a list of your NYTD survey-eligible young adults for your county at <u>dss.nytd.info@dhhs.nc.gov</u>.
- 2. Provide eligible participants with information about how to complete the survey, including the survey link and survey ID(CNDS).
- 3. Engage the survey-eligible young people and invite them to complete the survey. Eligible young adults may complete the survey in one of the following ways:
  - a. Online via this link: https://surveymax.dhhs.state.nc.us/TakeSurvey.aspx?SurveyID=mIML7m84
  - b. Email completed surveys via this link: <u>dss.nytd.info@dhhs.nc.gov</u>
  - c. Via their worker who completes the survey utilizing the above options
- 4. Please email <u>dss.nytd.info@dhhs.nc.gov</u> to confirm your survey submission of survey-eligible young adults and provide regular updates about efforts to reach out and invite these young adults to take the survey.
