SUBJECT: COVID-19 Vaccination Guidance for Children and Youth in the Custody of Local Departments of Social Services

Purpose: COVID-19 Vaccination Guidance Update; Vaccinations for ages 5-11

REQUIRED ACTION: □ Information Only □ Time Sensitive ⊠ Immediate

Child welfare has the statutory requirement to ensure safety, permanency, and wellbeing of children. Given the protection vaccines provide, it is essential that child welfare workers are informed regarding the use of COVID-19 vaccines for children and youth.

On November 2, 2021, the Pfizer-BioNTech COVID-19 vaccine received CDC endorsement by the CDC Advisory Committee on Immunization Practices' (ACIP) recommendation that children 5 to 11 years old be vaccinated against COVID-19 with the Pfizer-BioNTech pediatric vaccine.

The Pfizer COVID-19 vaccine is available under emergency use authorization (EUA) for use in individuals 5-15 years old and those 12 and over who may be eligible for an additional dose due to certain immunocompromised conditions. The FDA approved Pfizer BionTech COVID-19 vaccination (being marketed as COMIRNATY) is available for individuals 16 years of age and older.
