The North Carolina Department of Health and Human Services Division of Social Services (NCDHHS DSS) is committed to ensuring the safety and well-being of children and youth placed across state lines through the provision of interstate services. To support this effort, each county is assigned a designated Interstate Compact on the Placement of Children (ICPC) Consultant. Please refer to the attached document for the updated list of county assignments for each ICPC Consultant.

Additionally, the Interstate Compact on Adoption and Medical Assistance (ICAMA) safeguards the interstate rights of children with adoption assistance agreements when they move or are adopted across state lines. For assistance with ICAMA, please contact Karis Rozier, ICAMA Consultant, at Karis.Rozier@dhhs.nc.gov. As a reminder, when submitting interstate services requests, send all ICPC requests to nc.icpc@dhhs.nc.gov and all ICAMA requests to dss.icama@dhhs.nc.gov. Do not fax or mail any interstate services requests as this will cause delays in processing.
