SUBJECT: DCDL_CWS_45_2023_FUNDING MANUAL REVISIONS

REQUIRED ACTION: Information Only I Time Sensitive I Immediate

PURPOSE: NOTIFICATION OF REVISION TO ADOPTION ASSISTANCE FUNDING MANUAL

The Division is committed to providing counties with protocol and guidance to support compliance with federal and state law requirements. To ensure compliance with the federal requirements for adoption assistance, the instructions found in CWS-AL-01-14 have been added to the Adoption Assistance Funding Manual.

The revised manual changes include:

- Updating the <u>Contents of the Child's Adoption Assistance File</u> to include signed 5268's and dated printouts of the RIL 050 and RIL 060 for each prospective adoptive parent.
- Updating the <u>Criminal Records Check</u> to include instructions on the requirements for counties to completing the 5268, RIL 050, and RIL 060.
- Updating the Adoption Assistance monthly cash payment rate, which starts July 1, 2023.
