PURPOSE

This letter is to inform county agencies of legislative approval under SL 2023-14 for an increase to the administrative portion of the Child Placing Agency Cost Modeled Rate for foster care placements.

Update to Cost Modeled Rates

SL 2023-14 provided two increases for foster care payments that became effective July 1, 2023. Under section 6.7(a) the foster care board rates were increased and section 6.8 included a special appropriation to implement an increase to the administrative portion of the cost modeled rates for participating private providers.

Effective July 1, 2023 and ongoing the Cost Modeled Rate for Participating Child Placing Agencies will be:

Child Age Group	Maintenance Portion	Administrative Portion	Total Maximization Rate
0-5	\$ 702	\$ 1,152	\$ 1,854 / month
6 – 12	\$ 742	\$ 1,271	\$ 2,013 / month
13 and up	\$ 810	\$ 1,285	\$ 2,095 / month

Agencies should refer to the Child Placement and Payment System and Child Welfare System reports for allowable reimbursement amounts.

Continuation of Bridge funding for Congregate Care

In addition, SL 2023-14 Section 6.9 provided nonrecurring funds for the 2023-2024 fiscal year to assist counties with the federal funding loss for congregate care under the Families First Prevention Service Act and extend the current bridge funding allocation. Bridge funding distribution will continue under the current process. County agencies should continue to follow the original guidance provided for data entry.
