SUBJECT: CHANGES TO ADOPTION ASSISTANCE ELIGIBILITY

REQUIRED ACTION: Information Only Time Sensitive Immediate

The purpose of this letter is to provide counties with an update to several Adoption Assistance Eligibility changes that are effective July 1, 2024. Since the passage of the Fostering Connections Act, The Administration of Children and Families (ACF) has been phasing out needs-based requirements for Title IV-E Adoption Assistance payments. The phasing out was temporarily paused during the implementation of The Family First Prevention Services Act but has now resumed and will be complete after June 30, 2024. As of July 1, 2024, all children who are adopted from foster care in North Carolina will be considered "applicable children."

Adoption Assistance Eligibility requirements as of July 1, 2024:

Requirements that continue:

- Children will still need to be US citizens or qualified aliens
- Children will still need to meet the three special needs requirements
- Children will still need to meet one of the "other" requirements related to the child's placement in foster care.
- Requirement that is eliminated:
 - Regardless of a child's age, removal from a home that met the 1996 guidelines for AFDC will no longer be required.

Changes for Counties:

- New forms and policy effective July 1, 2024:
 - Revisions to Appendix 3.6, Adoption Assistance Funding Manual
 - A Revised Form 5012, Adoption Assistance Eligibility Checklist
 - A Revised Form 5013, Adoption Assistance Agreement
- Expectations for counties:
 - Counties should use the revised 5012 and 5013 for all adoptions after July 1, 2024.
