The North Carolina Department of Health and Human Services, Division of Social Services (NCDHHS DSS) remains committed to a consistent review and update of its Regulatory and Licensing forms to ensure current standards and best practices. This ongoing effort is essential to maintaining the integrity and relevance of our work with resource families across the state.

**Effective August 1, 2025**, the DSS-1515 Foster Home Fire Inspection Safety Report form is being revised to better align with evolving safety requirements and to enhance the protection of children in licensed foster homes. The revision was prompted by a noted increase in re-licensure applications indicating a greater number of bedrooms than were originally documented at the time of the initial licensure. This discrepancy raised concerns about whether all bedrooms were properly assessed for fire safety. To address this issue, the **updated DSS-1515 form** includes a specific question on the **total number of bedrooms in the home**. This addition ensures that fire inspectors evaluate each bedroom for compliance with fire safety standards, and thereby reinforcing our commitment to the well-being of children placed in foster care.
