SUBJECT: POSTPONEMENT OF THE TRANSITION FROM TIPS-MAPP TO MAPP FOUNDATIONS

PURPOSE: TO INFORM AGENCIES AND NC TIPS-MAPP LEADERS OF THE POSTPONEMENT AND CANCELLATION OF LEADER CERTIFICATION UPDATE SESSIONS

On May 23, 2025, <u>DCDL #CWS-30-2025</u> announced that the North Carolina Division of Health and Human Services, Division of Social Services (NCDHHS DSS) was transitioning from the TIPS-MAPP curriculum to the revised MAPP Foundations curriculum and provided dates and locations for the first three Leader Certification Updates the week of August 12-15, 2025. However, due to unforeseen circumstances, the transition to MAPP Foundations has been postponed until further notice and all *TIPS to MAPP Foundations Leader Certification Update* and the 8-day *MAPP Foundations New Leader Certification* courses will be rescheduled to a later date.

The surveys that were completed by current TIPS-MAPP leaders and the prioritization lists that agency supervisors sent to Barbara Young, MAPP Curriculum Coordinator, will be retained and utilized to prioritize enrollment when the transition resumes.
