Kinship Care Month is celebrated in September to recognize the importance of kinship caregivers who provide a home for children when their parents are unable to do so. Kinship caregivers can also include nonrelative kin who have a substantial relationship with a child, or a member of a state or federally recognized tribe, regardless of whether or not there is a substantial relationship with the child

NCDHHS DSS is excited to celebrate all kinship families that have opened their homes and hearts to children, youth, and families. NCDHHS DSS is committed to providing resources that can be accessed by county DSS and private agency staff to provide ongoing support for the work you do each day to support kinship families and the children and youth who are placed with them.
