START is a specialized child welfare service delivery model that has been shown, when implemented with fidelity, to improve outcomes for children and families affected by parental substance use and child maltreatment. The North Carolina Division of Social Services (NCDSS) has contracted with Children and Family Futures (CFF) to pilot START in ten (10) local Department of Social Services agencies.

NCDSS along with the START Training and Technical Assistance Program, will host an informational webinar for interested counties from 2:00 - 4:00pm on November 1, 2023.

This webinar will introduce the START Model, installation, and implementation processes, and accompanying technical assistance. Participants will have the opportunity to ask questions; answers will be shared verbally if time permits and in written form after the webinar.
