PURPOSE/BACKGROUND: TO SHARE TRAINING OPPORTUNITY FOR CHILD WELFARE STAFF AND SOLICIT TRAINING SPACES

We are excited to continue our partnership with **Kinnect**, an Ohio-based nonprofit dedicated to enhancing child welfare practices, to provide Family Search and Engagement training to our child welfare workforce. This furthers our prioritization to equipe our workforce with the tools and strategies that promote a *KinFirst* culture and strengthen kinship connections and deliver lasting results for families and children.

### 2025 Training Recap:

In 2025, Kinnect delivered 14 in-person training sessions across all seven regions to 346 state and county child welfare employees, including case workers and leaders from Intake through Permanency. Over 90% of participants found the training engaging, relevant, and worth recommending. Here is what some participants said they will do differently:

- "Exploring family members and their relationships to identify more than just immediate caregivers building networks of support." (Case worker, 1-5 years' experience)
- "Start earlier during the in-home process, looking for connections before crisis occurs." (Supervisor, 6-10 years' experience)
- "Implement resources for workers to use online and in the community to better engage families."
   (Supervisor, 6-10 years' experience)

# 2026 Training Preview:

In 2026, Kinnect will offer 14 in-person regional trainings to counties. This six-hour interactive course "S.E.E.K." (Search. Engage. Explore. Kinnect.) focuses on diligent search techniques, meaningful engagement, and skills for connecting and supporting kinship families. *Kinnect will offer 14 one-hour, virtual post-training coaching sessions after each in-person training. Participation in the S.E.E.K. course is required to join these sessions—this includes those who have attended in 2025.* We are also working with Kinnect to provide family search and engagement trainings to private child placing agencies and court partners throughout NC.

#### **Call For Hosts:**

We are seeking county child welfare agencies in each region to volunteer to host these regional training sessions that will occur between January and August 2026. Spaces must accommodate up to 60 attendees and include
