Purpose: Webinar "2022-2023 Child Welfare Policy & Practice Update"

The NC Division of Social Services is legislatively required to provide child welfare services staff with annual updated information on family-centered practices and state and federal laws. To meet this requirement, the Division will offer a 60-minute **mandatory** webinar recapping the changes to law, policy, and practice during the prior state fiscal year. This webinar is required of all child welfare staff and all who have oversight in child welfare including social workers, supervisors, program managers/administrators, and directors.
