## **DEAR COUNTY DIRECTORS OF SOCIAL SERVICES**

SUBJECT: NATIONAL TRAINING DEVELOPMENT CURRICULUM (NTDC) UPDATE

This communication serves as an important update to DCDL <u>CWS-12-2025</u>, which announced the temporary suspension of two training themes within the North Carolina—specific National Training and Development Curriculum (NTDC) for resource parent pre-service training. The themes, *Parenting Racially & Culturally Diverse Families* and *Sexual Development & Identity*, were placed under review following the implementation of Federal Executive Order 14168, effective January 20, 2025.

Spaulding for Children, the developer of NTDC, completed its review and replaced Parenting *Racially & Culturally Diverse Families* theme, with *Building Connections*. However, the *Sexual Development & Identity* theme could not be revised to meet the requirements outlined in Executive Order 14168. To ensure continued compliance with the ten-hour therapeutic training requirement under Rule 70E .1117, two new themes— *Cultural Connections* and *Sensory Integrations* are approved as replacements.

**Effective immediately**, agencies must resume use of the full NC NTDC curriculum, including the revised versions. Agencies must discontinue use of the temporary substitute training courses, Grief: How Resource parents can Cope with and learn from Loss and Suicide and Self-Injury in Children and Teens referenced in CWS-12-2025. Agencies must now use the updated NC-specific NTDC materials in all pre-service and ongoing training. The revised curriculum is available through Spaulding for Children's NTDC portal at <a href="https://www.ntdctraining.org/">https://www.ntdctraining.org/</a>. Three attachments accompany this communication which outlines the updated themes for foster care, therapeutic care, and kinship care training.

Thank you for your continued partnership and commitment to providing high-quality, compliant training for North Carolina's resource families.
