## **NC Kinship Family Foster Parent Pre-Licensure Training Curriculum**

Prior to the beginning of training, Licensing Staff should:

Show parent(s) how to access the Self-assessment and have them complete it.

## **Training Structure:**

- -Training is based on 15 hours, 15 hour reduced kinship track.
- -Note Trainings can be done in-person, virtually or hybrid. Pre/Post tests to be completed after each theme, can be completed electronically, must be provided to the trainer and submitted to the state to <a href="mailto:Cynthia.ogle@dhhs.nc.gov">Cynthia.ogle@dhhs.nc.gov</a>. Fidelity forms are filled out by trainer after the delivery of the themes and submitted to the state <a href="mailto:Cynthia.ogle@dhhs.nc.gov">Cynthia.ogle@dhhs.nc.gov</a>.

Right-Time Trainings delivered as instructor-facilitated group sessions must include the completion of Pre/Post tests for each theme. Instructors are required to follow the conversion instructions outlined in the Right-Time Training Guide for Support Group Leaders when adapting the content for group delivery. The Pre/Post tests can be completed electronically, must be provided to the trainer, and submitted to the state to <a href="mailto:Cynthia.ogle@dhhs.nc.gov">Cynthia.ogle@dhhs.nc.gov</a>

Instructor facilitated pre-licensure training can be completed in increments of 3, 4 or 5 sessions at agency discretion. All training hours must be completed in the order listed below.

If a kinship family wishes to pursue licensure as a family foster home to care for a child who is not related to them, they are required to complete an additional 15 hours of training beyond the standard kinship curriculum.

Therapeutic foster parents as kinship providers are not eligible for a reduction in licensing training hours. Kinship therapeutic foster parents must complete the full 30 training hours for family foster care and the additional 10 hours for therapeutic-specific training. Kinship therapeutic foster parents are required to complete a total of 40 training hours.
