## DEAR COUNTY DIRECTORS OF SOCIAL SERVICES

SUBJECT: PATH NC DATA AND DOCUMENT CONVERSION

PURPOSE: (1) IDENTIFY COUNTIES AND THE COUNTY DATA AND DOCUMENTS THAT EXIST OUTSIDE OF LEGACY SYSTEMS TO BE CONVERTED TO PATH NC & (2) IDENTIFY COUNTIES WITH INTEREST IN USING TEMPORARY WEB-SERVICE TO HELP CREATE ONGOING CASES IN THEIR LOCAL SYSTEMS FOR PERIOD OF TIME THEY ARE USING PATH NC FOR INTAKE & ASSESSMENT BUT NOT YET FOR ONGOING CASE MANAGEMENT

As part of our ongoing efforts to implement a high-quality child welfare information system (PATH NC) we are seeking information and input from counties to help us facilitate data and document conversion from local county systems into PATH NC. This process is to ensure that critical child welfare history that is currently maintained only in county-owned and operated electronic systems is accurately transferred and integrated into PATH NC at the point in time that county child welfare staff begin to use PATH NC.

A key component of this project involves the conversion of county data and documents containing child welfare case information not found in State legacy systems (i.e., NC FAST CWIS (Cúram), Central Registry and CPPS). Data and documents within legacy systems will be converted to PATH NC with no action needed by county agencies.

If your county has:

a) Significant child welfare case and participant data that goes beyond what is keyed into the State AND/OR legacy systems and is stored in a locally owned or licensed case management system;

b) Content such as documents and/or other types of files that are stored in a locally owned or licensed content management or document management system

We are offering an optional service to convert data and/or documents into PATH NC. If you are interested in converting county data and/or documents containing child welfare case information not found in State legacy systems, we request that you work with us to plan for the extraction and conversion of this data. To assist with this, we have provided an information sheet that outlines the criteria for document and data extraction as well as an outline of PATH NC Taxonomy, which is subject to change as our development effort continues.

These attachments will provide additional context for the necessary steps to prepare your data and documents for conversion.

Additionally, NC DHHS is working to provide an optional temporary web service that counties using a local technology system for ongoing case management could use to help bring over data from the PATH NC Intake and Assessment modules to make the creation of an ongoing case in the county's local system more efficient. Use of this web-service would be limited to the time period in which a county has implemented PATH NC for intake & assessment but not yet for ongoing case management. After this period of approximately 6 months, the web-service would be decommissioned as participating counties implement the PATH NC Ongoing Case Management modules.

We request that you complete a survey designed to help us better understand your current state, the nature of your data and documents, your county's general interest in having data and/or documents converted to PATH NC, your county's general interest in utilizing the temporary web service, and any specific requirements or challenges that you believe we need to know about in our planning.

We ask that you review the attached extraction criteria for document and data conversion and complete the survey by **Friday**, **December 13**, **2024**. County DSS leadership will need to collaborate with their local IT support staff and/or their system vendors in order to effectively respond to all of the questions in the survey. Your responses will greatly assist us in understanding your county's unique needs for data and document conversion into PATH NC and your interest in utilizing the temporary web-service.
