### DAAS Administrative Letter No. DAAS-11-10

**Subject:** Elimination of HCCBG Volunteer Program Development Funds

**Date:** June 22, 2011

The NC Division of Aging and Adult Services (DAAS) has been notified that the legislature has eliminated Volunteer Program Development as a service category under the NC Home and Community Care Block Grant (HCCBG). Effective July 1, 2011, the HCCBG will include 17 rather than 18 allowable services.

Although Volunteer Program Development was eliminated as a fundable service, the 11 counties currently funded for this service will not receive less HCCBG funding for FY 2011-2012 and the total amount of HCCBG funds available will not be reduced in the new fiscal year. Nevertheless, at a time when volunteer services are more important than ever, local providers that currently receive Volunteer Program Development funding will likely feel the effects of losing this service. Although these providers are no doubt already involved in collaborations with other local, state or national volunteer initiatives, we have attached a listing of some local, state and national volunteer programs that may serve as possible resources to the 11 affected counties and their service providers. This information should also be useful to all within the aging and adult services network.

# **National Volunteer Programs**

The following national volunteer programs and resources may be helpful to service providers that have been receiving HCCBG Volunteer Program Development funds:

### The Retired and Senior Volunteer Program (RSVP),

http://www.seniorcorps.gov/about/programs/rsvp.asp is America's largest volunteer network where people age 55 and over are connected to service opportunities in their communities. Sponsoring agencies provide supplemental insurance and may provide reimbursement for costs such as meals and transportation.

# United We Serve, a program of the Corporation for National and Community Service,

http://www.serve.gov/about.asp is a nationwide service initiative that helps meet growing social needs resulting from the economic downturn. This initiative aims to both expand the impact of existing organizations by engaging new volunteers in their work and encourage volunteers to develop their own "do-it-yourself" projects. A volunteer match service by town or zip code is part of this initiative.

# Local volunteer programs in the 11 counties currently funded for HCCBG Volunteer Program Development

Each of the 11 counties currently receiving Volunteer Program Development funds have one or more senior centers certified by DAAS as a Senior Center of Merit or a Senior Center of Excellence. Certified centers are required to have a volunteer program that connects seniors and the general public to volunteer opportunities with the center. Additionally, they are required to collaborate with the larger community to keep seniors informed about other volunteer opportunities outside of the senior center.

In some cases the senior center or its parent agency has been the recipient of the HCCBG Volunteer Program Development funds. Other organizations that were receiving Volunteer Program Development funds may wish to contact the certified center(s) in their county to discuss possibilities for collaboration. All senior centers and their certification level are listed for each of the 11 counties below.

The NC Commission on Volunteerism and Community Services provides support and resources to Volunteer Centers in NC. In some cases, the Volunteer Center is the agency receiving HCCBG Volunteer Program Development funds; however, the volunteer centers for all 11 counties are listed as a possible resource for those service providers that may not be connected to a Volunteer Center:

### Davidson:

Has a Level 2 volunteer center (internal to United Way of Davidson County). Lexington/Davidson County Senior Center, CENTER OF EXCELLENCE Thomasville Senior Center, CENTER OF EXCELLENCE

### Davie:

Is served by a Level 2 volunteer center in Forsyth County (internal to American Red Cross)

Davie County Senior Services, CENTER OF EXCELLENCE

Has a Level 2 volunteer center (internal to United Way of Randolph County)

Liberty Senior Center, CENTER OF EXCELLENCE

Randleman Senior Center, CENTER OF MERIT

### Rockingham:

Has a Level 1 volunteer connector organization (internal to Cooperative Extension) that provides basic volunteer center services

Madison-Mayodan Senior Center, CENTER OF EXCELLENCE

Rockingham Community College, CENTER OF EXCELLENCE

Reidsville Senior Center, CENTER OF EXCELLENCE

Stokes: Does not have a volunteer center or volunteer connector organization in the statewide network (closed the center last year; the Level 2 volunteer center in Forsyth County may begin serving Stokes County also)

Walnut Cove Senior Center, CENTER OF EXCELLENCE

Surry: Is served by a Level 2 volunteer center in Forsyth County (internal to American Red Cross)

Surry County Senior Center, CENTER OF EXCELLENCE

Pilot Mountain Senior Center (satellite of Surry County Senior Center)

### Yadkin:

Is served by a Level 2 volunteer center in Forsyth County (internal to American Red Cross)

East Bend Senior Center, CENTER OF EXCELLENCE

Yadkin County Senior Center, CENTER OF EXCELLENCE

Yadkin Valley Senior Center, CENTER OF EXCELLENCE
