SUBJECT: Authenticating NCID for Client Services Data Warehouse (CSDW) Access

I. BACKGROUND

Beginning October 1, 2013, the CSDW will require the NCID as the user ID when logging into the CSDW. Unless access has been updated to the NCID, users will no longer have access to the system.

II. AUTHENTICATING NCID PASSWORDS

A. Mapping Existing User IDs to NCID

To map existing user IDs to valid NCIDs the NCID Administrator/Security Officer must take the following actions:

- Identify all individuals accessing the CSDW using the three reports below which are available in the CSDW under the DHHS Main Document/ Security folder:
 - a) Security List of DSS County Users shows county users of the PM/REM (Economic Services, Services Information System and Child Welfare) data;
 - b) Security List of Child Care County Users shows county users of the Division of Child Development and Early Education systems data.
 - c) Security List of NCPC and Smart Start Local Partnership Users

 shows NCPC and Smart Start Local Partnership users of the Division
 of Child Development and Early Education systems data.

Note: State Child Support will handle access to the Child Support data in CSDW. Counties will not have to complete this process for those users. However, adding the NCID in the e-IRAAF system mentioned in #5 below may be required.

2) Individuals whose accounts are disabled are shown at the end of these reports. The disabled status indicates CSDW access has either been revoked for the user or the user has disabled his/her password. If the user requires CSDW access and is disabled due to a disabled password, the user should be listed on the spreadsheets along with his/her NCID. No action is required for disabled individuals who no longer need access.

Once the reports have been run for the county, they must be downloaded into Excel. Enter the NCID for each user who has CSDW access in the last column of each report. See the sample spreadsheet attached for the correct format.

- 3) If a user does not have an NCID, the NCID Administrator must assign an ID, and the spreadsheets must be updated with the new NCID. Be sure the user logs in with the NCID and temporary password so the NCID will be activated. Otherwise, these individuals will be unable to access the CSDW.
- 4) The three updated Excel spreadsheets should be password protected and emailed to Andy Raby at <u>Andy.Raby@dhhs.nc.gov</u> by the due date listed below. Please make sure your county name is listed on each report.

- 6) Counties will be notified once the spreadsheets have been processed. Users will be required to access the CSDW using their NCID.
- 7) In the future, an e-IRAAF submitted for CSDW access must contain the individual's NCID. This will prevent missing users who may have been given CSDW access after the Security Reports were completed.

B. EXPIRATION OF NCID PASSWORDS

Once the user is notified that the password is expiring, the user must use the NCID portal (<u>https://ncid.nc.gov/</u>) to change the password. A password used in the NCID system at any time in the past can not be reused.

NCID access may be disabled if the account has been inactive for at least 12 consecutive months.

III. IMPLEMENTATION

Effective October 1, 2013, all CSDW users must access the system using their NCID and password.
