SUBJECT: Medicaid Administrative Claiming for Adults and Children

As you know, At-Risk Case Management Services for Adults and Children terminated on June 30, 2014. **Effective July 1, 2014**, county departments of social services are allowed to claim reimbursement for a set of activities known as Medicaid Administrative Claiming (MAC) Please see link below.

The Divisions of Aging and Adult Services, Social Services, and Medical Assistance along with the Public Consulting Group jointly conducted webinars during the month of June and live classroom trainings beginning in July 2014. These trainings have provided an in-depth presentation of MAC and the allowable activities, including case examples as well as presenting the new SIS service codes and descriptions.

The Division of Medical Assistance has subsequently provided additional guidance to the Divisions of Aging and Adult Services and Social Services that outlines the framework for billing activities to MAC. The memorandum is the basis upon which the two divisions are conducting training, consultation, technical assistance, and monitoring beginning later this state fiscal year. (Please see link below)
