## 1.0 OVERVIEW

The Division of Mental Health, Developmental Disabilities and Substance Abuse Services (DMH/DD/SAS) is interested in implementing several pilot projects across the state implementing the use of digital tools; i.e., mobile health apps, to improve engagement, retention and outcomes for individuals with a substance use disorder and/or seeking recovery with a substance use disorder (SUD). Hundreds of recovery apps have been developed over the past several years to assist individuals in staying engaged in treatment services, tracking their recovery, and developing new strategies for long-term, sustained recovery. These apps became more critical during the pandemic with requirements for social distancing and need for self-quarantine because they allowed individuals the opportunity for social connectedness and access to other virtual resources.

The intent of this initiative is not to replace formal, clinical treatment services for SUD, but to provide additional tools to assist individuals who may have difficulty accessing treatment services as often as needed, or who may need digital recovery resources because options are limited in their area, or who may need or prefer additional support, particularly during times when other resources might not be available.

Digital tools can be personalized based on an individual's distinct needs and can result in improved general health outcomes, sustained recovery and positive improvements in various social determinants, including employability/employment and housing/housing stability. The utilization of these mobile apps can also result in fewer hospitalizations, ED visits and criminal involvement, which results in overall cost savings to health plans and individuals.

## 1.1 PURPOSE

The overarching goal of this initiative is to provide increased access to digital therapeutics, tools and/or mobile apps to individuals with a SUD who are interested in and could benefit from additional digital recovery supports. The Division will select up to two (2) organizations that promote, market and support a digital therapeutic/tool/mobile app that meets criteria further outlined in Section 5.1., and who are furthermore interested in working with treatment providers and/or recovery organizations to identify individuals interested in using this tool.

Grant funds may be used to cover the costs of the app, contingency management (if applicable) and other logistical costs needed to implement this initiative.

Funds may not be used to purchase phones, tablets or other electronic devices to be used by potential participants of this project.

### 2.0 ELIGIBILITY

Applicant agencies must meet the following eligibility criteria to be considered:

- Applicant agencies must:
  - be a non-profit\*
  - o not be currently subject to any investigative or corrective actions by any investigative body
- Applicants must demonstrate that they are able to provide the service specifications and standards set forth in this RFA. Award recipients must meet all applicable DMH/DD/SAS regulations and policies, and conditions and requirements for the Substance Abuse Block Grant (SABG) grant.
- Applicant agencies that are applying as part of a partnership must clearly identify the lead agency and the other partner agencies, the roles and responsibilities of each agency should be identified and

documentation confirming the partnership should be included in the appendices.

\*As these funds are tied to the Substance Abuse Prevention and Treatment Block Grant (SABG), those statutes restrict awards for "financial assistance to any entity other than a public or nonprofit private entity," as stated in 42 U.S.C. § 300x-31(a)(1)(E) (section 1931(a)(1)(E) of the Public Health Service Act); 45 C.F.R. §96.135(a)(5). However, the restriction does not apply in the context of contracts. Ordinarily, the term "financial assistance" is used to describe a grant relationship as distinguished from an acquisition (or procurement) relationship, typically funded by a contract. Therefore, while a state is precluded from providing grants to for-profit entities, states may enter into procurement contracts with for-profit entities.

## **3.0 AWARD INFORMATION**

The total amount of funding available in this RFA is \$400,000. Agencies may apply for a portion of these funds or the total amount. The anticipated period of award for this RFA is July 1, 2022 through March 14, 2023. Funds are contingent upon availability. Any extension will be contingent upon successful implementation of strategies and deliverables as defined by the implementation sites and agreed upon by the Division, as evidenced by the selection of awardees, and contingent upon award of such funds by the federal grantor.

As stated above, one (1) or more awards will be made through this RFA, and will be based on a thorough review of all submitted complete applications and will be allocated and monitored through DMH/DD/SAS.

Cost sharing or matching is not required.

## 5.0 SCOPE OF WORK

## 5.1 Programmatic requirements

Successful applicants for these funds will have the following expectations:

- Partner with one or more, treatment providers and/or recovery organizations that serve individuals with SUD who are uninsured or underinsured.
- Identify no less than five (5) areas across the state to target these efforts, with focus on rural, underserved, marginalized and resource poor areas or communities.
- Provide training, technical assistance and access to digital therapeutics/tools/mobile applications that support individuals' recovery efforts.
- Comply with reporting requirements outlined in section 5.4 of this RFA

## 5.2 OUTCOMES

Successful applicants for these funds will have the following outcome expectations:

- Expand and/or enhance the number of locations where digital recovery services and supports are available
- Increase the number of individuals with a SUD who are receiving recovery supports through digital means
- o Increased engagement with individuals, i.e., persons seen/served more than once
- Number of individuals connected to community-based resources such as treatment, social service agencies and peer support services
- o Decreases in referrals to higher level of care

## **5.3 PERFORMANCE STANDARDS AND EXPECTATIONS**

Applicants shall comply with all federal and state requirements for subawards. The <u>North Carolina State</u> <u>Budget Manual</u> outlines parameters for allowable and unallowable costs at the state level, and the code of federal regulations, title 2, part 200 outlines requirements and restrictions for sub awardees receiving federal awards. Sub awardees must comply with all uniform guidance related to the SAPTBG COVID-19 Supplement funding, CFDA: 93.959.

## **5.4 REPORTING REQUIREMENTS**

Successful applicants will be required to submit a monthly Financial Status Report (FSR) and a monthly program report. Both will be provided to the applicant post award.

The FSR will detail expenditure of the grant funds and the monthly program report will provide DMH/DD/SAS with data necessary to demonstrate program outcomes. Both reporting forms, including supporting documentation for the FSR (i.e., receipts, proof of payment, etc.) are to be submitted to the contract administrator by the 10<sup>th</sup> of each month.

Other reporting requirements will include:

- o Demographic information of service recipients
- o Service recipient satisfaction surveys

## **5.5 QUALIFICATIONS AND CAPACITY**

Sub awardees must have internal controls in place and use generally accepted accounting principles (GAAP). Successful applicants will show no more than two audit findings in their most recent audit. Successful applicants will have a proven track record of collaboration with community partners to conduct community based health research.

## **6.0 PERFORMANCE OVERSIGHT**

The Division of Mental Health, Developmental Disabilities and Substance Abuse Services assumes responsibility for monitoring the performance of the selected applicant and the outcome of this project.

## 7.0 TERM OF AWARD, OPTIONS TO EXTEND

The performance period for this project begins July 1, 2022 and ends March 14, 2023. The successful applicant project will be supported with funds from the SAPTBG COVID-19 Supplement funding. Funds are contingent upon availability. At this time, there is no indication that funds will be available beyond March 14, 2023. Any extension will be contingent upon successful implementation of strategies and deliverables as defined by the Division, as evidenced by the selection of an awardee, and contingent upon award of such funds by the federal grantor.

## 8.0 BUDGET

Funds for the Implementation of Digital Tools to Improve Engagement, Retention and Outcomes for Individuals with Substance Use Disorders will be awarded to the applicant(s) that achieves the highest score on the evaluation criteria below (see Section 13).

The line-item budget shall constitute the total cost to DMH/DD/SAS for the complete performance in accordance with the requirements and specifications herein, including all applicable expenses such as administrative cost. The applicant shall not invoice for any amounts not specifically allowed for in the line-item budget of this RFA.

Applicants should note in their budget the estimated number of individual participants.

## 9.0 REIMBURSEMENT

Upon award, a contract will be executed between DHHS and the awardee. Funds assoicated with this RFA will be provided to the successful applicant on a reimbursement basis. The successful applicant will be required to

submit a Financial Status Report (FSR) by the 10th of each month, detailing expediture during the reporting period. The FSR will be reviewed by the contract administrator against the approved budget. The FSR will then be processed for reimbursement.

## **10.0 THE SOLICITATION PROCESS**

The following is a general description of the process by which agencies or organizations will be selected to complete the goal or objective.

- 1) Written questions concerning the RFA specifications will be received until the date specified on the cover sheet of this RFA. A summary of all questions and answers will be posted on the RFA website.
- 2) Applications will be received from each agency or organization. The application must be signed and dated by an official authorized to bind the agency or organization.
- 3) All applications must be received by the funding agency not later than the date and time specified on the cover sheet of the RFA. Faxed applications will not be accepted.
- 4) Applications from each responding agency and organization will be logged in at the date and time received.
- 5) At their option, the evaluators may request additional information from any or all applicants for the purpose of clarification or to amplify the materials presented in any part of the application. However, agencies and organizations are cautioned that the evaluators are not required to request clarification; therefore, all applications should be complete and reflect the most favorable terms available from the agency or organization.
- 6) Applications will be evaluated according to completeness, content, experience with similar projects, ability of the agency's or organization's staff, cost, etc. The award of a grant to one agency and organization does not mean that the other applications lacked merit, but that, all facts considered, the selected application was deemed to provide the best service to the North Carolina residents.
- 7) Agencies and organizations are cautioned that this is a request for applications, and the funding agency reserves the unqualified right to reject any and all applications when such rejections are deemed to be in the best interest of the funding agency.

## **11.0 GENERAL INFORMATION ON SUBMITTING APPLICATIONS**

1) Award or Rejection

All qualified applications will be evaluated and awarded to the agency or organization whose capabilities are deemed to be in the best interest of the funding agency. The funding agency reserves the unqualified right to reject any or all offers if determined to be in its best interest.

Successful applicants will be notified no later than June 15, 2022.

2) Cost of Application Preparation

Any cost incurred by an agency or organization in preparing or submitting an application is the agency or organization's sole responsibility; the funding agency will not reimburse any agency or organization for any pre-award costs incurred.

## 3) Elaborate Applications

Elaborate applications in the form of brochures or other presentations beyond that necessary to

present a complete and effective application are not desired.

## 4) Oral Explanations

The funding agency will not be bound by oral explanations or instructions given at any time during the competitive process or after awarding the grant.

## 5) <u>Reference to Other Data</u>

Only information that is received in response to this RFA will be evaluated; reference to information previously submitted will not suffice.

## 6) <u>Titles</u>

Titles and headings in this RFA and any subsequent RFA are for convenience only and shall have no binding force or effect.

## 7) Form of Application

Each application must be submitted on the form provided by the funding agency.

## 8) Exceptions

All applications are subject to the terms and conditions outlined herein. All responses will be controlled by such terms and conditions. The attachment of other terms and condition by any agency and organization may be grounds for rejection of that agency or organization's application.

## 9) Advertising

In submitting its application, agencies and organizations agree not to use the results therefrom or as part of any news release or commercial advertising without prior written approval of the funding agency.

## 10) Right to Submitted Material

All responses, inquiries, or correspondence relating to or in reference to the RFA, and all other reports, charts, displays, schedules, exhibits, and other documentation submitted by the agency or organization will become the property of the funding agency when received.

## 11) Competitive Offer

Pursuant to the provision of G.S. 143-54, and under penalty of perjury, the signer of any application submitted in response to this RFA thereby certifies that this application has not been arrived at collusively or otherwise in violation of either Federal or North Carolina antitrust laws.

## 12) Agency and Organization's Representative

Each agency or organization shall submit with its application the name, address, and telephone number of the person(s) with authority to bind the agency or organization and answer questions or provide clarification concerning the application.

## 13) Subcontracting

Agencies and organizations may propose to subcontract portions of work, provided that their applications clearly indicate the scope of the work to be subcontracted, and to whom. All information required about the prime grantee is also required for each proposed subcontractor.

  - e) The "lessons learned" from each of those contracts.
- 5) Qualifications/background on organization's Key Staff.
- 6) Provide evidence of partnerships with other relevant agencies.
- 7) The details of:
  - a) Any criminal investigations pending against the applicant or any of their officers, directors, employees, agents, or subcontractors of which the applicants have knowledge or a statement that there are none.
  - b) Any regulatory sanctions levied against any of the applicants or any of their officers, directors, employees, agents, or subcontractors by any state or federal regulatory agencies within the past three years of which the applicant s have knowledge or a statement that there are none. As used herein, the term "regulatory sanctions" includes the revocation or suspension of any license or certification, the levying of any monetary penalties or fines, and the issuance of any written warnings.
  - c) Any regulatory investigations pending against of any of the applicants or any of their officers, directors, employees, agents, or subcontractors by any state or federal regulatory agencies of which the applicants have knowledge or a statement that there are none. Note: The Department may reject a proposal solely based on this information.

## E. Assessment of Need/s (Problem Statement) (10 points)

- 3) Include statistical facts and figures (national, state and regional).
- 4) Describe how this project might impact policy, outreach, services and outcomes.
- 5) Describe what your organization is and why your agency is interested in conducting this initiative, with this population.

## F. Project Description and Narrative (40 points)

- 1) Describe your proposed project.
- 2) Provide a description of your experience providing a similar scope of service/products in other states or communities.
- 3) Digital health products address a broad array of issues, depending on their purpose. How do you classify your product(s)? Is it considered digital wellness, diagnostic or a therapeutic or recovery intervention?
- 4) Provide a detailed overview of your product.
- 5) Provide your clinical evidence and outcomes specific to utilization of this application, including retention and average length of use; i.e., user engagement results.
- 6) Provide your most recent user satisfaction outcomes.
- 7) Describe how your product enhances or supports other services, including formal clinical treatment services, as well as other recovery supports.
- 8) Describe the use of contingency management principles for individuals utilizing this service, if applicable.
- 9) Describe how program payment will be structured; i.e., per participant, per month, or flat rate.
- 10) Provide information on potential or realized demonstrated savings through utilization of your product.
- 11) Identify potential challenges the project may face (site participation, data collection, logistic, or other constraints) and discuss how these challenges will be addressed and/or minimized.

## G. Collaboration and Support (10 points)

All applicant agencies must:

- 1) Describe how they will collaborate on this project with other relevant organizations, such as provider organizations.
- 2) Describe the reasons for partnering with specific organizations.
- 3) Describe how you will verify that projects or services are not being duplicated in the community and with the population served.

Letters of support that involve collaboration may be included with your grant application as an appendix and will not count toward the narrative page limit of this RFA. Please do not have letters sent separately to the Division. They will not be included in your application and will not be read by reviewers.

## H. Potential Impact (10 points)

Explain why the proposed project is a good use of federal dollars. Describe the potential health impact and other effects on North Carolina and its residents. Whenever possible, quantify the possible economic savings and/or gains brought about by the study through specific data.

## I. Line Item Budget and Budget Narrative (10 points) (Not inclusive in the 10 page limit)

<u>Line-Item budget:</u> Appendix C is a line-item budget template that is to be submitted with this RFA. This does not count towards the page limit of this RFA.

<u>Budget Narrative</u>: The budget narrative should be included in the body of the proposal and will count towards the page limit of this RFA.

Every item that appears in the budget should be explained clearly, so the evaluator/reviewer will understand it. The budget narrative should explain how the numbers in the budget were calculated and how each expense is related to the proposed project. The Budget Narrative is the justification of 'how' and/or 'why' a line item helps to meet the program deliverables. It is also used to determine if the cost in the contract is reasonable and permissible.

The budget should be for the period July 1, 2022 through March 14, 2023:

- Salary Detail Staff salaries and expenses for temporary/contract staff should be entered by position type in the appropriate section. For employed staff and temporary/contract staff, enter the average number of hours to be worked per week for each position type on the project.

- (b) Title to any INVENTION made or conceived solely by employees or students of either Contractor or Division in the performance of this Contract vests in the party whose employees or students made or conceived the INVENTION or discovery.

Publication: Contractor and its investigators are free to publish papers dealing with the results of the research project, if any, sponsored under this Contract. However, Division must be given thirty (30 days) to review such papers prior to any publication thereof. The Contractor shall acknowledge the Division's funding role in all publications. **Similar Research:** Nothing in this Contract may be construed to limit the freedom of the Contractor or of its researchers who are participants under the Contract from engaging in similar research made under grants, contracts, or agreements with parties other than the Division.

**Federal Intellectual Property Bankruptcy Protection Act:** The Parties agree that the Division shall be entitled to all rights and benefits of the Federal Intellectual Property Bankruptcy Protection Act, Public Law 100-506, codified at 11 U.S.C. 365(n), and any amendments thereto.

#### **Compliance with Applicable Laws**

**Compliance with Laws:** In the performance of this Agreement, the Contractor shall comply with all laws, ordinances, codes, rules, regulations, and licensing requirements that are applicable to the conduct of its business, including those of federal, state, and local agencies having jurisdiction and/or authority.

**Equal Employment Opportunity:** The Contractor shall comply with all federal and State laws relating to equal employment opportunity In the performance of this Agreement.

Health Insurance Portability and Accountability Act (HIPAA): The Contractor agrees that, if the Division determines that some or all of the activities within the scope of this contract are subject to the Health Insurance Portability and Accountability Act of 1996, P.L. 104-91, as amended ("HIPAA"), or its implementing regulations, it will comply with the HIPAA requirements in the performance of this Agreement and will execute such agreements and practices as the Division may require to ensure compliance.

#### Confidentiality

**Confidentiality:** Any medical records, personnel information or other items exempt from the NC Public Records Act or otherwise protected by law from disclosure given to the Contractor under this contract shall be kept confidential and not divulged or made available to any individual or organization without the prior written approval of the Division. Subject to the foregoing provisions, Contractor reserves the right to use the results of all services provided under this contract for its teaching, research and publication purposes, provided such use is otherwise permitted by applicable law.

**Data Security:** The Contractor shall adopt and apply data security standards and procedures that comply with all applicable federal, state, and local laws, regulations, and rules.

**Duty to Report:** The Contractor shall report a suspected or confirmed security breach to the Division's Contract

Administrator within twenty-four (24) hours after the breach is first discovered, provided that the Contractor shall report a breach involving Social Security Administration data or Internal Revenue Service data within one (1) hour after the breach is first discovered. During the performance of this contract, the contractor is to notify the Division contract administrator of any contact by the federal Office for Civil Rights (OCR) received by the contractor.

**Cost Borne by Contractor:** If any applicable federal, state, or local law, regulation, or rule requires the Division or the Contractor to give affected persons written notice of a security breach arising out of the Contractor's performance under this contract, the Contractor shall bear the cost of the notice.

#### Oversight

Access to Persons and Records: The State Auditor shall have access to persons and records as a result of all contracts or grants entered into by State agencies or political subdivisions in accordance with General Statute 147-64.7. Additionally, as the State funding authority, the Department of Health and Human Services shall have access to persons and records as a result of all contracts or grants entered into by State agencies or political subdivisions.

**Record Retention:** In accordance with the State's basic records retention policy, records resulting from these Services shall not be destroyed, purged or disposed of without the express written consent of the Division during the period specified in the Stat's records retention policy and in accordance with state and federal law. State basic records retention policy requires all grant records to be retained for a minimum of five years or until all audit exceptions have been resolved, whichever is longer. If the contract is subject to federal policy and regulations, record retention may be longer than five years. Records must be retained for a period of three years following submission of the final Federal Financial Status Report, if applicable, or three years following the submission of a revised final Federal Financial Status Report. Also, if any litigation, claim, negotiation, audit, disallowance action, or other action involving this Contract has been started before expiration of the five-year retention period described above, the records must be retained until completion of the action and resolution of all issues which arise from it, or until the end of the regular five-year period described above, whichever is later. The record retention period for Temporary Assistance for Needy Families (TANF) and MEDICAID and Medical Assistance grants and programs must be retained for a minimum of ten years.

**Government Review:** To the extent required by applicable law and pursuant to written requests from any appropriate governmental authority, Contractor and the Division shall make available to such appropriate governmental authority this Agreement and any books, records, documents and other records that are necessary to certify the nature and extent of the services provided and the cost claimed for services rendered pursuant to this Agreement or so as to otherwise comply with the requirements of any lawful agreement between the party and such governmental authority.

#### **Miscellaneous**

**Choice of Law:** The validity of this contract and any of its terms or provisions, as well as the rights and duties of the parties to this contract, are governed by the laws of North Carolina. The Contractor, by signing this contract, agrees and submits, solely for matters concerning this Contract, to the exclusive jurisdiction of the courts of North Carolina and agrees, solely for such purpose, that the exclusive venue for any legal proceedings shall be Wake County, North Carolina. The place of this contract and all transactions and agreements relating to it, and their situs and forum, shall be Wake County, North Carolina, where all matters, whether sounding in contract or tort, relating to the validity, construction, interpretation, and enforcement shall be determined.

**Amendment**: This contract may not be amended orally or by performance. Any amendment must be made in written form and executed by duly authorized representatives of the Division and the Contractor. The Purchase and Contract Divisions of the NC Department of Administration and the NC Department of Health and Human Services shall give prior approval to any amendment to a contract awarded through those offices.

**Severability:** In the event that a court of competent jurisdiction holds that a provision or requirement of this contract violates any applicable law, each such provision or requirement shall continue to be enforced to the extent it is not in violation of law or is not otherwise unenforceable and all other provisions and requirements of this contract shall remain in full force and effect.

**Headings:** The Section and Paragraph headings in these General Terms and Conditions are not material parts of the agreement and should not be used to construe the meaning thereof.

**Gender and Number:** Masculine pronouns shall be read to include feminine pronouns and the singular of any word or phrase shall be read to include the plural and vice versa.

**Time of the Essence:** Time is of the essence in the performance of this contract.

**Key Personnel:** The Contractor shall not replace any of the key personnel assigned to the performance of this contract without the prior written approval of the Division.

The term "key personnel" includes any and all persons identified by as such in the contract documents and any other persons subsequently identified as key personnel by the written agreement of the parties.

**Care of Property:** The Contractor agrees that it shall be responsible for the proper custody and care of any property furnished to it for use in connection with the performance of this contract and will reimburse the Division for loss of, or damage to, such property. At the termination of this contract, the Contractor shall contact the Division for instructions as to the disposition of such property and shall comply with these instructions.

**Travel Expenses:** Reimbursement to the Contractor for travel mileage, meals, lodging and other travel expenses incurred in the performance of this contract shall not exceed the rates published in the applicable State rules. International travel shall not be reimbursed under this contract.

**Sales/Use Tax Refunds:** If eligible, the Contractor and all subcontractors shall: (a) ask the North Carolina Department of Revenue for a refund of all sales and use taxes paid by them in the performance of this contract, pursuant to G.S. 105-164.14; and (b) exclude all refundable sales and use taxes from all reportable expenditures before the expenses are entered in their reimbursement reports.

**Advertising:** The Contractor shall not use the award of this contract as a part of any news release or commercial advertising.

#### **Conflict of Interest Policy Example**

The Board of Directors/Trustees or other governing persons, officers, employees or agents are to avoid any conflict of interest, even the appearance of a conflict of interest. The Organization's Board of Directors/Trustees or other governing body, officers, staff and agents are obligated to always act in the best interest of the organization. This obligation requires that any Board member or other governing person, officer, employee or agent, in the performance of Organization duties, seek only the furtherance of the Organization mission. At all times, Board members or other governing persons, officers, employees or agents, are prohibited from using their job title, the Organization's name or property, for private profit or benefit.

A. The Board members or other governing persons, officers, employees, or agents of the Organization should neither solicit nor accept gratuities, favors, or anything of monetary value from current or potential contractors/vendors, persons receiving benefits from the Organization or persons who may benefit from the actions of any Board member or other governing person, officer, employee or agent. This is not intended to preclude bona-fide Organization fund raising-activities.

B. A Board or other governing body member may, with the approval of Board or other governing body, receive honoraria for lectures and other such activities while not acting in any official capacity for the Organization. Officers may, with the approval of the Board or other governing body, receive honoraria for lectures and other such activities while on personal days, compensatory time, annual leave, or leave without pay. Employees may, with the prior written approval of their supervisor, receive honoraria for lectures and other such activities while on personal days, compensatory time, annual leave, or leave without pay. If a Board or other governing body member, officer, employee or agent is acting in any official capacity, honoraria received in connection with activities relating to the Organization are to be paid to the Organization.

C. No Board member or other governing person, officer, employee, or agent of the Organization shall participate in the selection, award, or administration of a purchase or contract with a vendor where, to his knowledge, any of the following has a financial interest in that purchase or contract:

- 2. Any member of their family by whole or half blood, step or personal relationship or relative-in-law;
- 3. An organization in which any of the above is an officer, director, or employee;
- 4. A person or organization with whom any of the above individuals is negotiating or has any arrangement concerning prospective employment or contracts.

D. **Duty to Disclosure** -- Any conflict of interest, potential conflict of interest, or the appearance of a conflict of interest is to be reported to the Board or other governing body or one's supervisor immediately.

E. **Board Action** -- When a conflict of interest is relevant to a matter requiring action by the Board of Directors/Trustees or other governing body, the Board member or other governing person, officer, employee, or agent (person(s)) must disclose the existence of the conflict of interest and be given the opportunity to disclose all material facts to the Board and members of committees with governing board delegated powers considering the possible conflict of interest. After disclosure of all material facts, and after any discussion with the person, he/she shall leave the governing board or committee meeting while the determination of a conflict of interest is discussed and voted upon. The remaining board or committee members shall decide if a conflict of interest exists.

In addition, the person(s) shall not participate in the final deliberation or decision regarding the matter under consideration and shall leave the meeting during the discussion of and vote of the Board of Directors/Trustees or other governing body.

**F.
