Reference: NC Electronic Income Withholdings

## Perdue Farms, Inc. accepts NC Electronic Income Withholdings (e-IWOs).

Review the "e-IWO Employers and FEINs" document on the Child Support Internal Website to determine if an NCP is employed by a Perdue Farms, Inc. employer that is processing e-IWO. This business has a variety of company names.

• If \*EIWO\* appears in the CONTACT PERSON field on Screen EMD (03.13.MPI#.F6) for the Perdue Farms, Inc. that is selected as the NCP's employer, follow the e-IWO procedures.

• If \*EIWO\* does not appear in the CONTACT PERSON field for the selected Perdue Farms, Inc. employer, use regular income withholding procedures.

When generating an income withholding for a Perdue Farms, Inc. that participates in e-IWO, case managers should follow e-IWO procedures for that employer beginning Monday, 06/27/11.

• A list of all the employers, FEINs, and Registered Agents currently participating in e-IWO with NC ("e-IWO Employers and FEINs") is available through the Child Support Internal Web Site. As new employers are added to the e-IWO process, the "e-IWO Employers and FEINs" link will be updated. The Child Support Policy & Procedures Manual no longer contains a list of the employers participating in e-IWO with NC.

### Best Buy accepts NC Electronic Income Withholdings (e-IWOs).

Review the "e-IWO Employers and FEINs" document on the CSE Internal Website to determine if an NCP is employed by a Best Buy employer that is using e-IWO. Each of these businesses has a variety of company names. If \*EIWO\* appears in the CONTACT PERSON field on Screen EMD (03.13.MPI#.F6) when the NCP's employer is selected, follow the e-IWO procedures. If \*EIWO\* does <u>not</u> appear in the CONTACT PERSON field, use regular income withholding procedures.

(Note: The Best Buy affiliates that are participating in e-IWO appear in the "e-IWO Employers and FEINs" document under Automatic Data Processing, Inc. (ADP), a company that provides payroll services for many businesses. Other businesses using ADP will be added to e-IWO in the future.)

When generating income withholding for a participating Best Buy, case managers should follow e-IWO procedures beginning Friday, 07/08/11.

As new employers are added to the e-IWO process, the "e-IWO Employers and FEINs" link will be updated.
